1. The market is a Farmers' Market. Primary sales will be farm products. Some craft / bakery type items will be allowed.
2. Farmers may partner with other local farmers to bring their product to market.
3. Farmers are responsible for liability insurance and compliance with any/all requirements of the State of Delaware.
4. All items for sale will be marked as such with clear pricing.
5. Any scale used for determining price will display a current legal inspection sticker.
6. Farmers will display their products in a clean and safe manner.
7. At the close of market Farmers will clean their immediate area and remove all boxes, packing materials and trash.
8. Vendors should operate their business in a professional manner at all times.
9. Vendors will supply their own tables and signage and be assigned a 20 ft. X 10 ft. space in the market.
10. This is not a discount market. Anyone engaging in price wars may be removed from the market.
11. Fees collected will be used for advertising and maintenance of the market area.
