Live Racing dates at Delaware Park for 2017?

81 live racing days were approved for 2017 in addition to 363 simulcasting days. For specific race track information can be obtained by going to the following web link: <http://www.delawarepark.com/>

Please note that simulcasting is conducted 7 days a week with the exception of Easter and Christmas.



How can I obtain a copy or review specific rules and regulations of the Delaware Thoroughbred Racing Commission?

How did the Stewards make their decision on a particular race? A disqualification? Or some other aspect that happened during the running of the race that you may have a question about.

There are three Stewards in the stand during the running of the races. Two of the Stewards actually watch the race live from the viewing stand high above the grandstand with binoculars. The third Steward views the running of the race via video feed from the track's film/video patrol service. Following the race, the Stewards may review the films of the race from several different angles so that they can see infractions that may occur. In cases where a foul is detected, they may change the order of finish accordingly. The Commission also employs a Safety Steward who monitors horse health and safety issues pertaining to racing participants.

How do I report any alleged neglect or horse abuse?

How do I report any alleged integrity problems or violations of rules of the Delaware Thoroughbred Racing Commission or Laws of the State of Delaware as it pertains to horse racing?

Any violations detected should be reported to John F. Wayne, Executive Director, DTRC at the contact number and e-mail address previously listed. All calls and or e-mails will be handled discreetly.



How can I apply for a license in the State of Delaware to run horses at Delaware Park?

Licensing is an easy process. You have several options, which are available. Delaware is a member of the National Racing Compact which is a governmental entity unto its own. Interested parties can access the web site of the National Racing Compact by going to URL: www.racinglicense.com or call them toll free at 1-877-457-2538.

You can also apply via the multi-jurisdictional license application located at the web site of the Association of Racing Commissioners International or www.arci.com and follow the on-line instructions. Their number is 1-859-224-7070.

Or you can come to the licensing office in person at Delaware Park and apply. The licensing office at Delaware Park is located off of the Stanton Route 4 entrance. The office building is adjacent to the Horsemen's Office and Stable gate. The telephone number for the licensing office is: (302) 994-2521 ext. 7138, 7258 or 7104.



How do I find out when a Commission meeting is scheduled?

The Commission meets at least once per month during live racing. In cases where they may be a heavy agenda of appeals, then additional meetings can be scheduled. The Commission is required to publicly post meeting notices and agendas 7 days prior to each meeting. What is the Delaware Jockey's Health and Welfare Benefit Board?

The Board was established to govern and monitor the health and welfare benefits available to participating Delaware Jockeys under the provisions of Senate Bill 338 signed into law in June, 2004. The Board meets periodically to discuss health care issues for eligible riders. All meetings are posted in accordance with the public meeting law and can be accessed in the same manner regular Commission meetings are posted.
