The film review concerned claims of foul by Mr. Saez and Mr. Spieth against Ms. Castrenze, in the 6<sup>th</sup> race on Monday, May 30, 2016. As a result of the hearing Ms. Castrenze will be issued a seven-day suspension for careless riding.

Jockeys Travis Wales, Kevin Mendez, and all apprentice riders are required to attend the film review today at 12:00 noon. The film review concerned a claim of foul by Mr. Mendez against Mr. Wales, in the 9<sup>th</sup> race on Monday, May 30, 2016. As a result of the hearing Mr. Wales will be issued a seven-day suspension for careless riding. Apprentice jockey Mr. Kevin Mendez, will be fined the sum of \$50.00 for failure to appear for the film review.
