**THIRD RACE – ON THE TURF - POST TIME – 2:15 p.m. OFF TIME – 2:17 p.m.**  
**INQUIRY FIRST TURN - Hold and claim of foul coming out of the clubhouse turn,** by #4, “Ocean Front View,” ridden by Scott Spieth, against the #6, “J C’s Not Brown,” with rider Erick Rodriguez for coming in out of the first turn causing him to check his mount. After reviewing the films and talking to the riders involved, the Stewards determined that the #6 did not come in; if anything the #5, “Rodie,” may have come out a half step coming out of the turn. The Stewards saw no reason to take any action and made the race official.
