### **Administrative:**

Two Jockeys and two Valets were randomly selected for testing today. All tests were negative.

Blood gas testing was suspended today as we did not have a technician available.

Dr. Jane Teichner is the substitute Associate Commission Veterinarian.

### **Equine Forensic Drug Testing:**

Post-race test results from Truesdail Laboratories, Inc. revealed the following:

- Workout Sample #17680 from June 19, 2016 is now clear.
- Workout Sample #17649 from June 18, 2016 is on hold.

Samples from June 15, 2016 were cleared, with the exception of #17614, #17619, #17626, #17635 and #17663 which were placed on hold.

Samples from June 9, 11, and 13, 2016 were cleared with the exception of #17695 on the 11<sup>th</sup> and #17695 on the 13<sup>th</sup> which were returned as positive for Glauicine.

Truesdail Laboratories, Inc. reported on their certificate of analysis for post-race test sample #17695 taken from the horse "Dennis' Diamond" which ran in the 5<sup>th</sup> race on Saturday, June 11, 2016, contained "Glauicine." The trainer of record, Mr. Scott Lake, was informed of the laboratory findings by the Stewards. This matter was placed on hold until final adjunction.

Truesdail Laboratories, Inc. reported on their certificate of analysis for post-race test sample #16191, taken from the horse "Jrock" which ran in the 1th race on Monday, June 13, 2016, contained "Glaucine." The trainer of record, Hugh McMahan, was informed of this laboratory finding by the Stewards. It is noted that Mr. McMahan is not stabled at Delaware Park. This matter was placed on hold until final adjunction.
