Administrative Hearings:

Truesdail Laboratories, Inc. reported that post-race test sample #17568, taken from the horse "Takemetoneworleans" which ran in the 8th race on Saturday, June 4, 2016, contained "triamcinolone acetonide," in the amount of 710 picograms per milliliter of plasma. The trainer of record, Mr. Herman Para, was informed of this laboratory finding by the Stewards. Trainer Para was informed of the positive by the Stewards. DTRC Inspectors conducted a barn inspection of Trainer Para's assigned area. Results of the inspection revealed no prohibited items. Mr. Para waived his rights to a split sample and a hearing in this matter and accepted a fine of Five-Hundred dollars (\$500.00) for this violation.
