Administrative:

Post-race test results from Truesdail Laboratories, Inc. revealed the following:

- All Samples from July 2, July 4, and July 7, 2016 were cleared.
- Samples from July 9, 2016 were cleared with the exception of #17834 and #17900 which were placed on hold.
- All graded stake samples from July 9, 2016 were cleared.
- All 30 out of competition samples taken during July, 2016 were cleared.

Administrative Hearings:

We held a hearing on Tuesday, July 19, 2016 for jockey Mr. Michael Sandoval concerning the excessive use of the riding crop on a horse while on the horse path after galloping. As a result of the hearing, Mr. Sandoval will be fined \$250.00 for this violation along with being placed on a conditional license.

Jockey Mr. Brian Pedroza came in this morning letting the Stewards know that he wanted to drop his appeal of the seven-day suspension issued on Monday, June 20, 2016 for careless riding. Mr. Pedroza will be suspended for seven calendar day from Sunday, July 24, 2016 through and including Saturday, July 30, 2016.
