Administrative Hearings:

Jockey Carol Cedeno filed an appeal to the Delaware Thoroughbred Racing Commission concerning Stewards ruling 63-2016 appealing her seven-day suspension for careless riding in the 1st race on Monday, August 15, 2016. *(The appeal was accepted by Executive Director Wayne via telephone and conveyed to Ms. Cedeno through the Stewards. Ms. Cedeno was advised that the appeal would be heard by the Commission at their next meeting on September 14, 2016).*

Jockeys Diego Gomez, Carol Cedeno, Jose Ferrer, and all apprentice riders are required to attend the film review today at 12:00 noon. The film review concerned claims of foul by Mr. Ferrer, and Ms. Cedeno against Mr. Gomez during the stretch run, in the 4th race on Wednesday, August 17, 2016. As a result of the hearing Mr. Diego Gomez will be issued a seven-day suspension for careless riding.

THIRD RACE – ON THE TURF - POST TIME – 2:16 p.m. OFF TIME – 2:18 p.m. Irvin Perez, named on #8, “Ruby’s Love,” was changed to Heribert Martinez; no double jocks mount. #1, “Isthums,” was scratched as a main-track only. #11, “Dreaming of Frank,” #12, “Next Right,” and #13, “Siena Indian,” were scratched as alternates.

FOURTH RACE – POST TIME – 2:48 p.m. OFF TIME – 2:49 p.m. Scott Spieth, named on #6, “Truth Only,” was changed to Travis Wales; no double jocks mount. #7, “Can’t Stop Believn,” was selected for a blood gas test.

ORDER OF FINISH – “3 - 5 - 2 - 6.” Starters - 9

FIFTH RACE – ON THE TURF - POST TIME – 3:19 p.m. OFF TIME – 3:23 p.m. Mychel Sanchez, named on #2, “The Iron Bank,” was changed to Tyler Conner; no double jocks mount. Josean Ramirez, named on #11, “Northern Hawk,” was changed to Marcelo Cardoso; no double jocks mount. #6, “Next Cowboy Up,” was a vet scratch. #12, “Monte Man,” #13, “Thomas Knight,” and #14, “Guy’s Big Guy,” were scratched as alternates. #5, “Marchant,” was selected for a blood gas test. **During the race:** #8, “Wild But Classy,” with rider Diego Gomez, pulled up at the five-eighths pole. Associate commission Veterinarian Jane Teichner reported that she could detect no infirmities with the horse. Following examination, the horse exited the racing surface its own power. Jockey Gomez had dismounted the horse and was uninjured. Jockey Ashley Castrenze was unseated from the #1, “Unbridled Copy,” after pulling up following the race. Jockey Ashley Castrenze was assessed at first aid by EMT Mandy Tgabem, who informed the Stewards that no injuries were noted or reported.

SIXTH RACE – POST TIME – 3:53 p.m. OFF TIME – 3:56 p.m. Scott Spieth, named on #6, “Josey Wales,” was changed to Keiber Coa; no double jocks mount. Ashley Castrenze, named on #2, “Hold Me Black,” was changed to Silvestre Gonzalez; no double jocks mount. The #1, “No Dozing,” unseated jockey Carol Ceden during the post parade, was subsequently caught by the outriders shortly after getting loose and was returned and re-mounted by jockey Ceden, to run in the race.
