Approved scratches for today, reviewed and filed veterinarian daily treatment sheets and blood gas test results.

Administrative:

Stewards Houghton and Lages attended the Delaware Thoroughbred Racing Commission meeting today at 10.05 a.m.

Dr. Craig Goldblatt is the substitute Associate Commission Veterinarian.

Post-race test results from Truesdail Laboratories, Inc. revealed the following:

- All samples from September 1, 3, and 5, 2016 were cleared.
- All 25 out of competition samples from September 4, 2016 were cleared. We are still waiting on results for 5 samples taken on September 11, 2016.

Administrative Hearings:

Jockeys Jevian Toledo, Jesus Bracho, and all apprentice riders were required to attend the film review today at 12:00 noon. The film review concerned claim of foul by Mr. Toledo, against Mr. Bracho during the stretch run, in the 7th race on Monday, September 12, 2016. As a result of the video evidence, Jockey Jesus Bracho will be issued a seven-day suspension for careless riding.

On another racing incident, Jockeys Scott Spieth, Alex Cintron, and all apprentice riders were required to also attend the film review concerning the claim of foul by Mr. Spieth, against Mr. Cintron during the stretch run in the 8th race on September 12th. Following review of the video evidence no action by the Stewards was deemed necessary.
