



## Daily Log Stewards Report Delaware Park

Approved scratches for today, reviewed and filed veterinarian daily treatment sheets and blood gas test results.

### **Administrative:**

Dr. Craig Goldblatt is the substitute Associate Commission Veterinarian.

### **Post-race test results from Truesdail Laboratories, Inc. revealed the following:**

- Samples from September 8, 10, and 12, 2016 were cleared with the exception of #18133, 17992, 18000, 18418, 17954, and #18312 which were placed on hold.
- All 30 out of competition samples from September 2016 were cleared.

### **Administrative Hearings:**

On Tuesday, September 20, 2016 we held a hearing for trainer Mr. Jason Forde, who was arrested by the Delaware State Police after admitting to the theft of \$1,000.00. Mr. Forde was summarily suspended pending his hearing before the Stewards. As a result of the hearing Mr. Forde was ordered to pay full restitution of the \$1,000.00 before being considered for reinstatement. When the full restitution of \$1,000.00 is made Mr. Forde will be reinstated with a conditional license.

Also on September 20<sup>th</sup> we scheduled a hearing for Exercise rider Cesar Montenegro-Ramos, who had allegedly received some of the money from the theft by Mr. Forde. Mr. Montenegro-Ramos failed to attend this scheduled hearing after notice by letter and phone. Mr. Montenegro-Ramos will be suspended pending his appearance before the Stewards, and the payment of a \$100.00 fine issued on, August 25, 2016 for being disrespectful to the outrider while in performance of his duties.

**FOURTH RACE – ON THE TURF - POST TIME – 2:45 p.m. OFF TIME – 2:47 p.m.**  
**INQUIRY IN THE STRETCH RUN. - Hold and claim of foul** by jockey Jonathan Gonzales on the #3, “Tyr,” against the #2, “Ranger’s Coming,” ridden by Jose Lopez. The claim of foul was in reference to the #2, coming in during the stretch run bumping the #3 and causing the rider to check his horse, impeding his progress. After interviewing the riders involved and based on video evidence, the Stewards disqualified the #2, from first and placed him second behind the #3 who was moved up from second to first. Jockeys Jose Lopez and Jonathan Gonzales. are required to attend the film review for this race on Thursday, September 22, 2016. #7, “Double Loui,” was scratched as a main-track only.

**ORDER OF FINISH – “3 - 2 - 6 - 9.” Starters - 9**

**FIFTH RACE – POST TIME – 3:18 p.m. OFF TIME – 3:19 p.m.** #7, “Wilburn’s Princess,” was a vet scratch.

**ORDER OF FINISH – “5 - 4 - 1 - 2.” Starters - 8**

**SIXTH RACE – ON THE TURF - POST TIME – 3:48 p.m. OFF TIME – 3:49 p.m.**  
#13, “Pontius P.,” and #14, “Thurgood,” were scratched as alternates. #1, “Summer Solution,” was selected for a blood gas test. #3, “Osceola Pond,” was eased at the quarter pole walking off the racing surface under his own power. Jockey Daniel Centeno, who was not unseated was hit in the face by something during the race and taken to first aid to be evaluated. Mr. Centeno was assessed at first aid by EMT Matt Paladinetti, who informed the Stewards that no injuries were noted or reported.
