Approved scratches for today, reviewed and filed veterinarian daily treatment sheets and blood gas test results.

Administrative:

Dr. Jane Teichner and Kristen Pastir are the substitute Associate Commission Veterinarians. Christina Cutler is the fill-in blood gas inspector.

- Samples from September, 21, 2016 were cleared, with the exception of #17906 which was placed on hold.

Administrative Hearings:

- A hearing was held on Thursday, September 29, 2016 for Owner - Trainer Mr. Richard Vega for failure to have a proper bill of sale and transfer from the Stewards on the horse "PURIM'S GOLD" prior to the 9th race on Thursday, September 22, 2016. The Stewards scratched the horse "Purim's Gold" from the 9th race on Thursday, September 22, 2016, due to the ownership of the horse being in dispute. As a result of the hearing Mr. Vega was ordered to release the horse to the original owner Mr. Winston Ricketts.

An agreement between owner Winston Ricketts and Trainer Vega took place on the disposition of purse money earned by "PURIM'S GOLD" in all 2016 starts at Delaware Park.

FIRST RACE – POST TIME – 1:15 p.m. OFF TIME – 1:16 p.m. #4, "My Man Dan,"
was selected for a blood gas test.

ORDER OF FINISH – "1 - 2 - 3 - 5." Starters - 7

SECOND RACE – POST TIME – 1:45 p.m. OFF TIME – 1:46 p.m. #5, "Five Shadwell,"
was scratched by the racing office to re-enter. #6, "Casanova Way," was scratched by its trainer. #8, "Pallium Prize," was selected for a blood gas test.

ORDER OF FINISH – "2 - 7 - 3 - 8." Starters - 6

THIRD RACE – POST TIME – 2:15 p.m. OFF TIME – 2:16 p.m. #6, “Rock On Wye,” was scratched by its trainer due to track conditions. #3, “Wendy Wend,” was claimed by Ponies & Poker LLC – Scott Lake.

ORDER OF FINISH – “2 - 4 - 1 - 8.” Starters – 8

FOURTH RACE – POST TIME – 2:45 p.m. OFF TIME – 2:46 p.m. Jose Lopez, named on #1, “The Real Lefty,” was changed to Marcelo Cardosa; no double jocks mount. #6, “Kitty Bank,” was selected for a blood gas test. Larry Mejias, the rider on the #3, “Callingmissbrown,” had his stirrup break at approximately the half-mile pole. Mr. Mejias kicked his foot out of the remaining stirrup, finishing the race with no stirrups.

ORDER OF FINISH – “3 - 5 - 4 - 6.” Starters - 6

FIFTH RACE – OFF THE TURF - POST TIME – 3:15 p.m. OFF TIME – 3:16 p.m. This race was scheduled at seven and one half furlongs on the turf, but ran at one mile on the main track. #1, “Miss Kitty Blue,” #2, “Virginia Envy,” #5, “Hydro,” and #11, “Kissthebutterflies,” were scratched as this race was taken off the turf.

ORDER OF FINISH – “9 - 10 - 8 - 6.” Starters - 7

SIXTH RACE – POST TIME – 3:45 p.m. OFF TIME – 3:46 p.m. #2, “My Team,” was scratched by its trainer due to track conditions. #7, “Aim Straight,” was a vet scratch. #6, “Spivey,” was selected for a blood gas test. #4, “Rally With Class,” was claimed by Jagger Inc. – Jamie Ness. #6, “Spivey,” was scratched by the Stewards as the jockey Diego Gomez, declined to ride the horse.

ORDER OF FINISH – “4 - 5 - 10 - 8.” Starters - 7

SEVENTH RACE – OFF THE TURF - POST TIME – 4:15 p.m. OFF TIME – 4:15 p.m. Scott Spieth, named on #1a, “Octavia Hill,” was changed to Ricardo Chiappe; no double jocks mount. #1, “Moonlight Basin,” was scratched as part of a same-owner entry. #2, “Passing Pfast,” #4, “So Royal,” #6, “Atlanta Babe,” #8, “Honor N Grace,” #9, “Hazel W,” #10, “Birkenhead,” #11, “Stranahan Dragon,” and #12, “Sugar Cane Girl,” were scratched as this race was taken off the turf. We canceled Exacta, Trifecta, Superfecta and Show wagering for this race as we were below four betting interests.

ORDER OF FINISH – “3 – 1a - 5.” Starters - 3

EIGHTH RACE – POST TIME – 4:45 p.m. OFF TIME – 4:46 p.m. #4, “Renee’s Cat,” was scratched by its trainer on account of track conditions. A claim in for the #6, “Messer Misfit,” was **VOID** under the name of Ocala West One – Anthony Russo. The claim form was not filled out correctly. The name of the owner should have been Ocala West One LLC.
