The counselor must send the Stewards a written evaluation and recommendation, along with a negative test result before a reinstatement hearing will be considered.

#3, “Lucky Rascal,” was scratched to re-enter. #2, “Racy (GB),” #6, “Gensum,” and #9, “Silent Tale,” were scratched as this race was taken off the turf. #7, “Joe Tess,” was scratched by the assistant trainer for the race being off the turf, but the horse ran yesterday at Laurel Park. #11, “Alfredo Romana,” was selected for a blood gas test.

Gerald Brooks, the trainer of “Macho Spaces” will be sent a hearing notice for this rule violation. (“Macho Spaces” past performance record showed numerous starts on dirt surfaces) #3, “Not Today,” #6, “Parting Gift,” #7, “Court’n Asong,” and #8, “Bronx City Boy,” were scratched as this race was taken off the turf. #5, “After the Cut Off,” was selected for a blood gas test.
