Stewards Ruling*

(111-2016)

A report from Truesdail Laboratories, Inc., the official Chemists of the Delaware Thoroughbred Racing Commission, showed that the blood and urine sample 18859, taken from the horse "North Forest Star", who finished first in the ninth race on Wednesday, September 28, 2016, tested positive for "Clenbuterol". The trainer of this horse, Mr. Wallace Neilson, RCI Id 2018543, DOB 1/23/1942, waived his right to a split sample.

As a result of the positive, Mr. Neilson waived his right to a hearing, and under the authority of the Stewards, refer to D.T.R.C. 3.3.1, 3.3.3, 3.3.10, 3.4.1, 3.4.1.7, Mr. Neilson was found to be in violation of D.T.R.C. Rules 7.3.1, 7.3.6, 7.3.9, 10.8.1.3, 15.1.1.1, 15.1.1.2, 15.1.2.2, 15.1.2.6, 15.1.2.7, 15.1.3.1, 15.1.3.1.1, 15.1.3.1.2 and 15.3.2. Mr. Neilson is fined the sum of five hundred (\$500.00) dollars and suspended fifteen (15) calendar days from Sunday, October 16, 2016, through and including Sunday, October 30, 2016. During the period of his suspension, he shall be denied the privileges of all grounds under the jurisdiction of the Delaware Thoroughbred Racing Commission. Refer to D.T.R.C. Rules 3.4 and 18.1. Fine must be paid within 48 hours. Also for a class 3 drug violation Mr. Neilson shall incur Two (2) Points towards the ARCI Medication point system.


The horse "North Forest Star" is disqualified from all purse monies in the ninth race on Wednesday, September 28, 2016. The purse is ordered redistributed as follows: 1st -Roundelay; 2nd -King James Court; 3rd -Handsome Senor; 4th-Love the Beat; 5th-White Bluff; 6th-In Condition; 7th-Lucky Prospector; 8th-Fifteen Black; 9th-Speedy Mexican; 10th-North Forest Star. This ruling in no way affects the pari-mutuel wagering in this race. Refer to D.R.C. Rules 17.6.1 and 17.7.
