**Delaware Park  
Stewards Ruling**

(46-2016)

*A report from Truesdail Laboratories Inc., the official Chemists of the Delaware Thoroughbred Racing Commission, showed that the blood sample 17768, taken from the horse "RB Nash", who finished first in the eighth race on Thursday, June 23, 2016, tested positive for "Phenylbutazone" in the amount of 11.9 micrograms per milliliter of plasma. The trainer of this horse, Mr. Gary Scott Powell, RCI 1899874, DOB 04/27/1965, waived his right to a split sample.*

*As a result of the positive, Mr. Powell waived his right to a hearing and under the authority of the Stewards, refer to D.T.R.C. 3.3.1, 3.3.3, 3.3.10, 3.4.1, 3.4.1.7, Mr. Powell was found to be in violation of D.T.R.C. Rules 7.3.1, 7.3.6, 7.3.9, 10.8.1, 10.8.1.3, 15.1, 15.1.1.1, 15.1.1.2, 15.1.2.2, 15.1.2.6, 15.1.2.7, 15.1.3.1, 15.1.3.1.1, 15.1.3.1.2, 15.1.3.1.3, 15.1.3.1.4, 15.1.3.1.5, 15.3.1. Mr. Powell is hereby fined the sum of five hundred (\$500.00) dollars, due to mitigating circumstances Mr. Powell will not be suspended. This Violation shall incur One (1) Point towards the ARCI Medication point system. Refer to D.T.R.C. Rules 3.3, 3.4, 3.4.1.3 and 3.4.1.15. Fine must be paid within 48 hours.*

*The horse "RB Nash" is disqualified from all purse monies in the eighth race on Thursday, June 23, 2016. The purse is ordered redistributed as follows: 1st – Lady HaHa; 2nd – Quick Sand AA; 3rd – Chndakasexpress; 4th – In X Hess; 5th – A Ladys Man; 6th – Sergeant Pepper MHF; 7<sup>th</sup> – RB Nash.. This ruling in no way affects the pari-mutuel wagering in this race. Refer to D.R.C. Rules 17.6.1 and 17.7.*
