Stewards Ruling

(62-2016)

A report from Truesdail Laboratories, Inc., the official Chemists of the Delaware Thoroughbred Racing Commission, showed that the blood sample 18429, taken from the horse "Harley's Joy", who finished first in the ninth race on Monday, August 1, 2016, tested positive for "Phenylbutazone" and "Flunixin". The Trainer of this horse, Ms. Sandra Kite, RCI Id 1960027, DOB 2/7/1948, waived her right to a split sample.

Ms. Kite, waived her right to a hearing and under the authority of the Stewards, refer to D.T.R.C. 3.3.1, 3.3.3, 3.3.10, 3.4.1, 3.4.1.7, Ms. Kite was found to be in violation of D.T.R.C. Rules 7.3.1, 7.3.6, 7.3.9, 10.8.1, 10.8.1.3, 15.1, 15.1.1.1, 15.1.1.2, 15.1.2.6, 15.1.2.7, 15.1.3.1, 15.1.3.1.1, 15.1.3.1.2, 15.1.3.1.3, 15.1.3.1.4, 15.20 and 15.20.1 And is hereby fined the sum of five hundred (\$500.00) dollars and suspended for fifteen (15) calendar days from Friday, August 19, 2016 through and including Friday, September 2, 2016, for stacking. The horse "Harley's Joy" will have to pass a veterinarian inspection and blood test at the Owner's expense and it has to be clear before the horse can be entered to race.. During the period of her suspension, she shall be denied the privileges of all grounds under the jurisdiction of the Delaware Racing Commission. This Violation shall incur Two (2) Point towards the ARCI Medication point system. Refer to D.T.R.C. Rules 3.3, 3.4 and 3.4.1.15. Fine must be paid within 48 hours


The horse "Harley's Joy" is disqualified from all purse monies in the ninth race on Monday, August 1, 2016. The purse is ordered redistributed as follows: 1st – Lightness; 2nd – Bringhamthecrown; 3rd– Xtra Blue; 4th– Terry Blossom; 5th–Doublicious; 6th–Harley's Joy. This ruling in no way affects the pari-mutuel wagering in this race. Refer to D.R.C. Rules 17.6.1 and 17.7.
