
**Delaware Park
Stewards Ruling**

(98-2016)

A report from Truesdail Laboratories, Inc., the official Chemists of the Delaware Thoroughbred Racing Commission, showed that the blood and urine sample 17954, taken from the horse "Big Silver Hoss", who finished first in the fourth race on Monday, September 12, 2016, tested positive for "Levamisole". The trainer of this horse, Mr. Gerald Bennett, RCI Id 2018826, DOB 3/12/1944, waived his right to a split sample.

Mr. Bennett waived his right to a hearing and under the authority of the Stewards, refer to D.T.R.C. 3.3.1, 3.3.3, 3.3.10, 3.4.1, 3.4.1.7, Mr. Bennett was found to be in violation of D.T.R.C. Rules 7.3.1, 7.3.6, 7.3.9, 10.8.1, 10.8.1.3, 15.1, 15.1.1.1, 15.1.1.2, 15.1.2.2, 15.1.2.6, 15.1.2.7, 15.1.3.1, 15.1.3.1.1, 15.1.3.1.2, 15.1.3.1.3 and 15.3.1 Mr. Bennett is fined the sum of Five Hundred (\$500.00) dollars and suspended fifteen (15) calendar days from Sunday, October 16, 2016, through and including Sunday, October 30, 2016. During the period of his suspension, he shall be denied the privileges of all grounds under the jurisdiction of the Delaware Thoroughbred Racing Commission. Refer to D.T.R.C. Rules 3.4, 3.4.1.15 18.1, 18.1.1 and 18.1.4 Fine must be paid within 48 hours. Also for a class 2 drug violation on a non-controlled substance Mr. Bennett shall incur Four (4) Points towards the ARCI Medication point system.


The horse "Big Silver Hoss" is disqualified from all purse monies in the fourth race on Monday, September 12, 2016. The purse is ordered redistributed as follows: 1st -Big Saver; 2nd -Royal Brute; 3rd -Envision Success; 4th-Love the Beat; 5th-Circular Thunder; 6th-Big Silver Hoss. This ruling in no way affects the pari-mutuel wagering in this race. Refer to D.T.R.C. Rules 17.6.1 and 17.7.
