Equine Forensic Drug Testing

We received test clearances from Dalare Associates for May 12, 2012 which were clear, with the exception of Sample #D-06223, which was placed on hold for further testing.

FIRST RACE – POST TIME – 1:15 pm. OFF TIME – 1:17 pm. The rider on the #3, “Maximoso,” Mr. Jorge Rodriguez was changed to Mr. Brian Pedroza by the trainer; double jocks mount will be charged. #6, “Silent Money,” was selected for a blood gas test.

FOURTH RACE – POST TIME – 2:46 pm. OFF TIME – 2:47 pm. #1, “Legacy Wildcat,” was scratched as part of a same-owner entry. **ORDER OF FINISH – “1a - 4 - 5 - 3.”**

FIFTH RACE – POST TIME – 3:17 pm. OFF TIME – 3:19 pm. #1, “Starsonhershoulder,” was a vet scratch. #3, “Morrow Cove,” was selected for a blood gas test. We canceled Superfecta wagering for this race as we were below six betting interests.

SIXTH RACE – POST TIME – 3:46 pm. OFF TIME – 3:53 pm. #7, “Written Word,” was scratched by the racing office to re-enter. The rider on the #1, “Quarto,” Mr. Daniel Centeno was changed to Mr. Able Mariano, as Mr. Centeno, is riding the other part of the same-owner entry. The rider on the #4, “Country Home,” Mr. Yamil Rosario, was changed to Mr. Hiram Rivera by the trainer; no double jocks mount. #4, “Country Home,” was scratched in the post parade for not warming up well upon recommendation by Associate Commission Veterinarian, Kathleen Picciano. **ORDER OF FINISH – “1 – 1a - 5 – 6 - 3.”**

SEVENTH RACE – THE JOSEPH FRENCH MEMORIAL OVERNIGHT STAKES - POST TIME – 4:20 pm. OFF TIME – 4:21 pm. #4, “Cherokee Artist,” was scratched as this is a stakes race. **ORDER OF FINISH – “7 - 3 - 6 - 1.”**

EIGHTH RACE – THE DELAWARE PARK SEASON OPENER ARABIAN DISTAFF - ARABIANS - POST TIME – 4:49 pm. OFF TIME – 4:51 pm. #3, “Awethenitk,” was scratched as this is a stakes race. The rider on the #2, “Arabellas Dream,” Mr. Yamil Rosario, was changed to Mr. Ricardo Santana Jr., by the trainer; no double jocks mount. #5, “Sanddpiper,” was selected for a blood gas test. A change of equipment “Blinkers Off” for the #4, “Ms Dixie,” was disallowed by the Stewards. The horse had won her last start with blinkers. It is noted that the trainer, Mr. Scott Powell, did not request a change of equipment off the win from the Stewards. **ORDER OF FINISH – “5 - 4 - 6 - 7.”**
