Approved scratches for today, filed ambulance transport reports from management, veterinarian daily treatment sheets, and blood gas test results.

**Administrative**

Neil Crowther, an Assistant trainer who had taken the Trainers test on Thursday, May 24, 2012, has passed with a score of 80%. Mr. Crowther came in this morning to go over the missed questions, and receive his certificate of accomplishment.

We requested Chief Commission Veterinarian John Peters, talk to Trainer Mr. Bill Waldron about being close to the limit on the blood gas test for the ninth race on Monday, May 28 2012. The horse "Aim Hi," was close to the limit of 12.4 for Salix horses. With test sample results of 11.4 and 11.5 for total base excess, levels Mr. Waldron was issued a second warning. Commission Inspector Mr. Francis Swift was also contacted about this matter, and is inspecting Mr. Waldron's barn again for products that would cause an elevated ph reading.

**FIRST RACE – POST TIME – 1:15 pm. OFF TIME – 1:17 pm. #1, "Later Gator," was scratched as part of a same-owner entry. #4, Stolen Chevy," was claimed by Sola Dei Gloria Stable – Hugh McMahon. ORDER OF FINISH – "4 - 5 - 7 – 1a."**

**SECOND RACE – POST TIME – 1:45 pm. OFF TIME – 1:48 pm. #1a, "Lost Resolve," was scratched as part of a same-owner entry. #2, "Marshall Earp," was a vet scratch. #3, "Mr Orlando," was selected for a blood gas test. We canceled Superfecta wagering for this race as we were below six betting interests. ORDER OF FINISH – "4 - 6 - 1 - 5."**

**THIRD RACE – POST TIME – 2:15 pm. OFF TIME – 2:16 pm. ORDER OF FINISH – "3 - 6 - 2 - 1."** We had a three minute tote delay in making this race official.

**FOURTH RACE – ON THE TURF - POST TIME – 2:44 pm. OFF TIME – 2:47 pm. #4, "Thatleaveamark," was scratched as a main-track only. ORDER OF FINISH – "9 - 1 - 2 - 8."**

**FIFTH RACE – POST TIME – 3:15 pm. OFF TIME – 3:16 pm.** The rider on the #2, “Caleb’s Prayer,” Mr. Victor Rodriguez, was changed to Mr. Alex Canchari; no double Jocks mount. The rider on the #5, “March Ink,” Mr. Javier Velez, was changed to Mr. Gregorio Rivera; no double Jocks mount. #7, “Holy Mo,” was selected for a blood gas test. **ORDER OF FINISH – “1 - 8 - 4 - 2.”** **INQUIRY AT THE FINISH LINE –** The outriders gave the all clear for this race. The rider of the #4, “Monroe’s Hope,” Ricardo Santana Jr. did not put the race on hold, but claimed foul against the #1, “Best and Final,” Mr. Luis Garcia for coming out and bumping him just before the finish. After reviewing the films of the race and talking to the riders involved, it looks like the #1 does come out right at the finish line bumping the #4. No action was taken as this happened at the finish line.

**SIXTH RACE – POST TIME – 3:45 pm. OFF TIME – 3:48 pm.** #2, “Stevia,” was selected for a blood gas test. **ORDER OF FINISH – “3 - 5 - 4 - 1.”**

**SEVENTH RACE – ON THE TURF - POST TIME – 4:14 pm. OFF TIME – 4:18 pm.** #2, “Balto More,” was scratched as a main track only. **ORDER OF FINISH – “4 - 5 - 8 - 3.”**

**EIGHTH RACE – POST TIME – 4:47 pm. OFF TIME – 4:51 pm. ORDER OF FINISH – “7 - 3 - 6 - 4.”** **INQUIRY STRETCH –** Hold and claim of foul by the #6, “Disco Elvis,” Mr. Luis Garcia,” against the #3, “Avarice,” Mr. Brian Pedroza for coming out bumping him in mid stretch. After reviewing the films of the race and talking to the riders involved, it looked to us as though the #6 came in and the #3 came out at the point where they made contact. No action was taken.

**NINTH RACE – ARABIANS - POST TIME – 5:18 pm. OFF TIME – 5:20 pm.** #1a, “Aim South,” was scratched as part of a same-owner entry. #1, “Aim Hi,” was selected for a blood gas test. **ORDER OF FINISH – “3 - 2 - 5 - 6.”**
