Equine Forensic Drug Testing

We received notification from Dalare Associates for nine horses' that were tested for the presence of "Boldenone" at the request of trainer Juan Vazquez. The samples were collected on Tuesday, June 12, 2012. The laboratory report that all nine test samples were clear.

Administrative

We held movies today concerning the stretch run in the first race on Sunday, June 17, 2012. Apprentice Jockey, Yomar Orlando Ortiz, will be suspended for seven calendar days, for careless riding in the stretch which resulted in the disqualification of his mount "Orange's Lil Sis" from first to second.

FIRST RACE – POST TIME – 1:15 pm. OFF TIME – 1:16 pm. #1, "Indy Krizz," was scratched as part of a same-owner entry. #2, "Quarters," was a vet scratch. We canceled Superfecta wagering for this race as we were below six betting interests. #5, "Alex's Vision," was claimed by Jan Meehan & John Petika – Greg Griffith. **INQUIRY AT START** – It looked to us as though the #5, "Alex's Vision," ridden by Javier Santiago, was throwing his head when the starter started the race, breaking slow. The rider told us that the horse was trying to flip when the starter started the race, which caused him to break slow. **ORDER OF FINISH – "1a - 6 - 5 - 4." Starters – 5**

SECOND RACE – POST TIME – 1:45 pm. OFF TIME – 1:47 pm. We had to remove the rider on the #2, Apprentice jockey Ivan Sabol, as he could not get within the five pound overweight limit to ride the horse. The rider on the #2, "Oh Please," Ivan Sabol was changed to Robert Paz. No double jocks mount. #2, "Oh Please," ridden by Robert Paz, was eased at the seven-eighths pole and subsequently pulling up after the race. "Oh Please," was examined by Associate Commission Veterinarian Jane Teichner, who said the horse was off in the right front. Dr. Teichner requested the horse ambulance transport the horse back to its stall. **ORDER OF FINISH – "3 - 4 - 5 - 7." Starters - 7**

No double jocks mount. #2, “Risky Recovery,” was scratched by the racing office to re-enter. #8, “Cave Creek Road,” was selected for a blood gas test. #7, “Pure Innocence,” was sent for a Stewards special test. **ORDER OF FINISH – “6 - 3 - 1 - 4.” Starters - 7**

OFF TIME – 3:17 pm. #3, “Warrensburgh,” and #7, “Tizsilk,” were scratched as main-track only. #6, “Vigilante Law,” was selected for a blood gas test. #6, “Vigilante Law,” was claimed by Kryskaly Horse Racing Inc - Julio Cartagena. **ORDER OF FINISH – “6 - 8 - 10 - 5.” Starters - 9**

SIXTH RACE – POST TIME – 3:46 pm. OFF TIME – 3:47 pm. #6, “Dimension,” was selected for a blood gas test. **ORDER OF FINISH – “5 - 6 - 3 - 1.” Starters - 6**

SEVENTH RACE – POST TIME – 4:16 pm. OFF TIME – 4:19 pm. The rider on the #6, “Spun Yarn,” Able Castellano Jr.; was changed to Alex Cintron. No double jocks mount. #1, “Flatter Me Up,” was a vet scratch. #2, “Great Motion,” was scratched in the post parade by Associate Commission Veterinarian Jane Teichner for not warming up well. **ORDER OF FINISH – “5 - 8 - 4 - 7.” Starters - 7**

EIGHTH RACE – ON THE TURF - POST TIME – 4:47 pm. OFF TIME – 4:48 pm. The rider on the #2, “Bullet Catcher,” Wesley Ho, was changed to Juan Torres. No double jocks mount. #3, “Battle Harbour,” and #7, “Big Sur,” were scratched as main-track only. #10, “Standup Comic,” was scratched by the racing office to re-enter. #9, “Cusabo,” was selected for a blood gas test. **ORDER OF FINISH – “6 - 5 - 12 - 1.” Starters - 10**

NINTH RACE – ARABIANS - POST TIME – 5:15 pm. OFF TIME – 5:16 pm. #1a, “Destinee Rich,” was scratched as part of a same-owner entry. **ORDER OF FINISH – “2 - 4 - 3 - 1.” Starters - 7**
