FIFTH RACE – POST TIME – 3:10 p.m. OFF TIME – 3:11 p.m. #2, “Christmas on Dixon,” was a vet scratch. #5, “Trick of Mirage,” with rider Robert Paz, started falling back at the three-eighths pole, and was pulled up down the stretch. Associate Commission Veterinarian, Jane Teichner said the horse had fractured the right rear pastern, and was humanely destroyed. Postmortem report to follow. **ORDER OF FINISH – “8 - 3 - 1 - 4.” Starters - 7**
