We approved scratches for today, reviewed and filed veterinarian daily treatment sheets, and blood gas test results.

Administrative Hearings:

Apprentice Jockey Victor Rodriguez, has filed an appeal to the Delaware Thoroughbred Racing Commission pertaining to his suspension. The suspension was for extremely careless riding at the three eighths pole which caused his horse to clip heels and fall in the second race on Saturday, August 25, 2012; also for the fourth race on Saturday, August 25, 2012 for pushing another rider with his hand during the running of the race at the quarter pole.

FIRST RACE – POST TIME – 3:30 p.m. OFF TIME – 3:30 p.m. Victor Rodriguez, the scheduled rider on the #1, “Pleasant Hymn,” was changed to Jose Montano; no double jocks mount. #2, “Sexy Sandbagger,” and #5, “Gagne,” were vet scratches. #6, “Wakina,” was selected for a blood gas test. We canceled Trifecta, Superfecta, and Show wagering for this race as we were below five betting interest. #6, “Wakina,” was claimed by Glen Gaddy – Thomas Iannotti IV. #3, “Marie’s Babe,” was scratched in the post parade for not warming up well, upon recommendation by Associate Commission Veterinarian, Kathleen Picciano.
