**FIRST RACE – POST TIME – 1:15 p.m. OFF TIME – 1:17 p.m.** #4, “Downhill Dale,” was selected for a blood gas test. The #5, “My Friend Dr Joe,” ridden by Jose Caraballo, pulled up lame at the top of the stretch. The #5 was examined by Associate Commission Veterinarian Richard Brown, who said the horse was lame in the left front ankle. The horse ambulance was requested to transport the horse back to its stall. We received a call from Associate Commission Veterinarian Jane Teichner at 3:38 P.M. stating that private practitioner Dr. Grace Burns, euthanized the #5, “My Friend Dr Joe,” for a fractured left front sesamoid. Post mortem report to follow. **ORDER OF FINISH – “1 - 3 - 6 - 2.” Starters - 7**

**SECOND RACE – POST TIME – 1:44 p.m. OFF TIME – 1:46 p.m.** #3, “My Nobleman,” was a vet scratch. After a two-way shake, #6, “Eyelite,” was claimed by Juan Arriagada – Heather Hollahan. **ORDER OF FINISH – “6 - 7 - 5 - 1.” Starters - 6**

**THIRD RACE – POST TIME – 2:15 p.m. OFF TIME – 2:16 p.m.** #2, “Sconce,” was a vet scratch. A claim in for the #7, “Silent Sister,” by Manfred Roos John Rigattieri – John Rigattieri, was “VOID” as no race number was entered on the claim blank. **ORDER OF FINISH – “7 - 6 - 5 - 4.” Starters - 6**

was scratched for being ineligible for the race conditions. **ORDER OF FINISH – “3 - 6 - 1**  
**- 2.” Starters - 6**

**FIFTH RACE – ON THE TURF - POST TIME – 3:15 p.m. OFF TIME – 3:19 p.m. #7,**  
“Socio D’oro,” and #9, “El Pinchon,” were scratched as main-track only. #11, “Hold True,”  
was scratched by the racing office. #2, “Daddy Likes That,” was selected for a blood gas  
test. **ORDER OF FINISH – “3 - 8 - 2 - 5.” Starters - 8**

**SIXTH RACE – POST TIME – 3:48 p.m. OFF TIME – 3:49 p.m. #1, “Peace Cat,”** was  
scratched as part of a same-owner entry. **ORDER OF FINISH – “5 – 1a - 4 - 2.” Starters**

Juan Torres, the scheduled rider on the #3, “Zany Viola,” was changed to Yamil Rosario; no  
double jocks mount. Kristina McManigell, the scheduled rider on the #10, “Romolo’s Juliet,”  
was changed to Ricardo Feliciano; no double jocks mount. #12, “Autumn Wind,” and #13,  
“Well Traveled,” were scratched as alternates. #9, “Poignant,” was selected for a blood gas  
test. **ORDER OF FINISH – “7 - 5 - 10 - 11.” Starters - 11**

**EIGHTH RACE – “THE DOVER STAKES” - POST TIME – 4:46 p.m. OFF TIME –**  
4:48 p.m. Ricardo Feliciano, the scheduled rider on the #1, “Hoofing Cat,” was changed to  
Francisco Maysonett; no double jocks mount. Paco Lopez, the scheduled rider on the #3, “Keep  
the Canoli,” was changed to Jose Ferrer; no double jocks mount. #2, “Carol’s Jimmy,” #7,  
“Yougottthatgoinformu,” and #8, “Micromanage,” were scratched as this is a stakes race. #5,  
“Seventeenohsix,” was selected for a blood gas test. **ORDER OF FINISH – “1a - 3 - 6 – 1 -**  
**4.” Starters - 7**

**NINTH RACE – “THE DELAWARE PARK ARABIAN DISTAFF CLAIMING**  
**CHAMPIONSHIP STAKES” - POST TIME – 5:16 p.m. OFF TIME – 5:16 p.m.** Santos  
Chavez, the scheduled rider on the #7, “Se Deci,” was changed to Huber Villa Gomez; no double  
jocks mount. #2, “Arabellas Dream,” and #5, “Grate Fire,” were scratched as this is a stakes  
race. **ORDER OF FINISH – “6 - 9 - 3 - 8.” Starters - 7**
