Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, and blood gas test results.

Associate Commission Veterinarian Nancy Vutz, is substituting today.

Four Jockeys were randomly selected today for testing. All tests were negative.

Trainer Jose Corrales was informed telephonically on Monday, October 15, 2012 of his "Phenylbutazone" positive in the amount of 4.48 micrograms per milliliter of plasma, concerning the horse "Silber Stern" Blood Sample D-07245. "Silber Stern" finished first in the fifth race on Saturday, October 6, 2012. Mr. Corrales having waived his right to a split sample, and a Stewards hearing is accepting the five hundred (\$500.00) dollar fine, for a first offense of the "Phenylbutazone" overage over 2.0 but under the amount of 4.5 under rule 15.1.3.1.5

Trainer Rudy Rodriguez was informed telephonically on Monday, October 15, 2012 of his "Phenylbutazone" positive in the amount of 3.42 micrograms per milliliter of plasma, concerning the horse "Carolyn Shines" Blood Sample D-07211. "Carolyn Shines" finished first in the first race on Monday, October 8, 2012. Mr. Rodriguez having waived his right to a split sample, and a Stewards hearing is accepting the five hundred (\$500.00) dollar fine, for a first offense of the "Phenylbutazone" overage over 2.0 but under the amount of 4.5 under rule 15.1.3.1.5

FIRST RACE – POST TIME – 1:15 p.m. OFF TIME – 1:16 p.m. Brian Pedroza, the scheduled rider on the #4, "Fast Shadow," was changed to Yamil Rosario; no double jocks mount. #5, "Marie's Babe," was a vet scratch. We canceled Superfecta wagering for this race as we were below six betting interests. **ORDER OF FINISH – "6 - 2 - 3 – 1a."**

SECOND RACE – POST TIME – 1:45 p.m. OFF TIME – 1:46 p.m. The main track has been downgraded to “Good” starting with this race. #3, “S K R’s Spartan,” and #8, “Wild Doone,” were vet scratches. After a two-way shake, #5, “Malicious,” was claimed by Raul Arriagada – Heather Hollahan. **ORDER OF FINISH – “5 - 2 - 1 - 7.” Starters - 6**

THIRD RACE – POST TIME – 2:15 p.m. OFF TIME – 2:16 p.m. The main track has been downgraded to “Muddy” starting with this race. #3, “Apologize,” was scratched for track conditions. #7, “My Sonata,” was a vet scratch. #7, “Pow Wow Wow,” was selected for a blood gas test. **ORDER OF FINISH – “7 - 2 - 5 - 4.” Starters - 5**

FOURTH RACE – POST TIME – 2:45 p.m. OFF TIME – 2:46 p.m. Alex Cintron, the scheduled rider on the #1, “Gail’s Jewel,” was changed to Julian Pimentel; no double jocks mount. #6, “Flower Patch,” was a vet scratch. #4, “Misty’s Rebellion,” was sent for a Stewards special test. **ORDER OF FINISH – “3 - 7 - 1 - 2.” Starters - 6**

FIFTH RACE – OFF THE TURF - POST TIME – 3:15 p.m. OFF TIME – 3:16 p.m. Brian Pedroza, the scheduled rider on the #5, “Flashy Bullet,” was changed to Yamil Rosario; no double jocks mount. Alex Cintron, the scheduled rider on the #9, “No Play,” was changed to Julian Pimentel; no double jocks mount. #1, “School House,” and #3, “Concorde Express,” were scratched as this race is off the turf. #6, “Garryowen,” and #10, “Hunter Jak,” were scratched as main-track only. **ORDER OF FINISH – “9 - 4 - 8 - 7.” Starters - 6**

SIXTH RACE – POST TIME – 3:45 p.m. OFF TIME – 3:46 p.m. Brian Pedroza, the scheduled rider on the #1, “J Double F,” was changed to Sarah Rook; no double jocks mount. #7, “Birds on Venus,” was selected for a blood gas test. The rider on the #5, “Ragin Wildfire,” Robert Paz, lost his right stirrup out of the gate. Mr. Paz got his foot back in the stirrup about seventy yards out of the gate, going on to finish the race. **ORDER OF FINISH – “9 - 7 - 3 - 4.” Starters - 9**

SEVENTH RACE – OFF THE TURF - POST TIME – 4:15 p.m. OFF TIME – 4:15 p.m. #3, “Secluded Way,” #9, “Manis,” and #10, “Well Traveled,” were scratched as this race is off the turf. #6, “Nitros Account,” was a vet scratch. #1, “Not for Grace,” was selected for a blood gas test. **ORDER OF FINISH – “11 - 5 - 4 - 2.” Starters - 7**

EIGHTH RACE – POST TIME – 4:45 p.m. OFF TIME – 4:46 p.m. Alex Cintron, the scheduled rider on the #2, “Lucky Lady Lawyer,” was changed to Julian Pimentel; no double jocks mount. Felix Ortiz, the scheduled rider on the #7, “G’s Little Girl,” was changed to Ricardo Feliciano; no double jocks mount. **ORDER OF FINISH – “3 - 2 - 4 - 7.” Starters - 8**
