**FIRST RACE – POST TIME – 1:15 pm. OFF TIME – 1:16 pm.** The trainer of the #7, “My Espresso,” failed to ship the horse necessitating a scratch. The trainer of the #7, “My Espresso,” Mr. Alex Correa, will be issued a hearing notice for this violation. **ORDER OF FINISH – “1a - 1 - 3 – 6 - 2.”**

**SECOND RACE – ON THE TURF - POST TIME – 1:45 pm. OFF TIME – 1:47 pm.** #5, “Smarty ‘N Me,” was scratched as a main track only. #8, “Grand Tier,” was a vet scratch. #6, “Slicklinghall,” Jeremy Rose was being eased down the stretch, the rider jumped off with the horse falling just prior to the finish line. Associate Commission Veterinarian Kathleen Picciano examined the #6, “Slicklinghall,” and diagnosed that it had sustained a possible heart attack. Due to the catastrophe the horse was transported off the racing surface by the horse ambulance. Post mortem report to follow. **ORDER OF FINISH – “4 – 1a - 2 - 9.”**
