Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, and blood gas test results.

Administrative:

Trainer Heather Hollahan will start her seven-day suspension on Sunday, August 12, 2012 through and including Saturday, August 18, 2012. The suspension was a result of her “PHENYLBUTAZONE” positive, in the amount of 5.22 micrograms per milliliter of plasma detected in the horse “Tropical Deputy” from the eleventh race on Saturday, July 21, 2012.

Trainer, Peter Wasiluk Jr. came in this morning concerning his “PHENYLBUTAZONE” positive in the amount of 2.88 micrograms per milliliter of plasma. The positive was for the horse “Prima Dea” who won the first race on Wednesday, August 1, 2012. Mr. Wasiluk has waived his right to a hearing accepting the penalty of a five hundred (\$500.00) dollar fine for a first offense of the “PHENYLBUTAZONE” overage over 2.0 but under the amount of 4.5 micrograms per milliliter of plasma.

An assistant trainers test was administered by the Stewards to Mr. Baltazar Galvan today Mr. Galvan is currently licensed as a horse owner.

NINTH RACE – ARABIANS - POST TIME – 5:15 p.m. OFF TIME – 5:15 p.m. The rider on the #1a, “Robert Paz, was changed to Gregorio Rivera; double jocks mount will be charged. #1, “Trayton,” and #6, “Cayucos,” were scratched by the racing office to re-enter. #2, “A F Ania,” was scratched as part of a same-owner entry. #2b, “A F Cheveyo,” was selected for a Stewards special test. **ORDER OF FINISH – “5 - 7 – 2b - 4.” Starters - 6**
