We approved scratches for today, reviewed veterinarian daily treatment sheets, and blood gas test results.

Administrative Hearings:

We held a hearing on Tuesday August 14, 2012 for Jockey Abel Mariano, for alleged theft in the stable area and jockey's room. As a result of the hearing Mr. Mariano will receive a thirty-day suspension, and was ordered to pay restitution in the amount of two-hundred-fifty (\$250.00) dollars to the victim.

A Trainers exam was administered by the Stewards on Tuesday August 14, 2012 to Mr. Oscar Power. Mr. Power passed the trainers exam and will be issued a certificate for his accomplishment.

FIRST RACE – POST TIME – 1:15 p.m. OFF TIME – 1:16 p.m. #3, “Yukon Special,” was selected for a blood gas test. #3, “Yukon Special,” was claimed by Gordon Policastro – Kelly Deiter. **ORDER OF FINISH – “3 - 5 - 4 - 6.” Starters - 6**

SECOND RACE – OFF THE TURF - POST TIME – 1:45 p.m. OFF TIME – 1:46 p.m. #1, “Osceola Prince,” was a vet scratch. #3, “Virginia Cavalier,” #5, “Safety Valve,” #8, “Cryin’ Ryan,” and #9, “Averil’s Ring,” were scratched as this race is off the turf. #2, “Giopi (IRE),” was selected for a blood gas test. We canceled Trifecta, Superfecta, and Show wagering for this race as we were below five betting interests. **ORDER OF FINISH – “7 - 6 - 4 - 2.” Starters - 4**

THIRD RACE – POST TIME – 2:15 p.m. OFF TIME – 2:16 p.m. #6, “Five Star Brew,” was scratched by the racing office to re-enter. #3, “Alluvials Princess,” was selected for a blood gas test. **ORDER OF FINISH – “5 - 1 - 2 - 7.” Starters - 6**

FOURTH RACE – OFF THE TURF - POST TIME – 2:45 p.m. OFF TIME – 2:45 p.m. #5, “Shepherd’s Furey,” and #10, “Storm Palm (ARG),” were vet scratches. #7, “Nellie,” was scratched by its trainer. #1, “Trouble in Love,” #11, “Emily’s Spirit,” #12, “Sisterinlaw,” #13, “Controlled Neglect,” and #14, “Bering Lass,” were scratched as this race is off the turf. **ORDER OF FINISH – “4 - 3 - 9 - 8.” Starters - 6**

FIFTH RACE – POST TIME – 3:15 p.m. OFF TIME – 3:18 p.m. #6, “Sweet Yulianna,” was a vet scratch. #1, “Magic Mesa,” was selected for a Stewards special test. **ORDER OF FINISH – “5 - 4 - 2 - 7.” Starters - 6**

SIXTH RACE – POST TIME – 3:44 p.m. OFF TIME – 3:46 p.m. The rider on the #1, “Racing Thoughts,” Forest Boyce, was changed to Julian Pimentel; no double jocks mount. **ORDER OF FINISH – “3 – 1a - 4 – 1 - 5.” Starters - 9**

SEVENTH RACE – OFF THE TURF - POST TIME – 4:15 p.m. OFF TIME – 4:21 p.m. #1a, “Disco Barbie,” was scratched as part of a same-owner entry. #4, “Secret Score,” Julian Pimentel flipped behind the gate prior to the start and was caught by the outriders. After being returned to the gate, “Secret Score” was examined by Associate Commission Veterinarian, Kathleen Picciano advising that the horse was fit to race. Jockey Pimentel who was unseated, was examined by the EMT on site and okayed to continue riding. Mr. Pimentel then remounted the horse without further incident. #2, “Day Dream Girl,” ridden by Jonathan Joyce, broke down pulling up after the race. “Day Dream Girl,” was examined by Dr. Kathleen Picciano, and diagnosed that the horse sustained a fracture to its left front leg. Subsequently, the horse was humanely destroyed. Jockey Joyce had dismounted the horse and appeared to be uninjured, but reported to first aid as a precaution. It was later reported that Joyce did not sustain any injury as a result of the incident. **ORDER OF FINISH – “5 - 2 - 3 - 4.” Starters - 7**

EIGHTH RACE – POST TIME – 4:45 p.m. OFF TIME – 4:45 p.m. #2b, “Happy Choice,” and #8, “Bella Promessa,” were vet scratches. #10, “Leroi’s Royal Lass,” was scratched by the racing office to re-enter. #1a, “Shameless,” #2, “Tell Me Everything,” #3, “Mykindofladyfriend,” #6, “Power of Gold,” and #7, “Doe Run,” were scratched as this race is off the turf. **ORDER OF FINISH – “1 - 11 - 9 - 5.” Starters - 6**

NINTH RACE – ARABIANS - POST TIME – 5:15 p.m. OFF TIME – 5:16 p.m. #6, “Butch Cassidy LZP,” was selected for a blood gas test. **ORDER OF FINISH – “3 - 6 - 1 - 2.” Starters - 6**
