We approved scratches for today, reviewed and filed veterinarian daily treatment sheets, ambulance transport reports from management and blood gas test results.

### Equine Forensic Drug Testing:

Post-race test results from Dalare Associates for Wednesday, August 8, and Thursday, August 9, 2012, were all clear.

Sample D-6953 collected from “WARRENSBURG,” winner of the third race on August 6, 2012, was found to be positive for “Stanozolol” (™ Winstrol V). The official laboratory, Dalare Associates, reported that the levels were 337 picograms per milliliter of plasma. Trainer, Donald Barr was informed of the positive test result and was scheduled for a hearing at 11:00 a.m. on August 28, 2012.
