**FIRST RACE – POST TIME – 1:15 p.m. OFF TIME – 1:16 p.m. ORDER OF FINISH – “4 - 2 - 6 - 7.” Starters - 8**

**SECOND RACE – POST TIME – 1:45 p.m. OFF TIME – 1:45 p.m. #6, “Silverest,” was selected for a blood gas test. ORDER OF FINISH – “6 - 5 - 3 - 1.” Starters - 6**

**THIRD RACE – ON THE TURF - POST TIME – 2:15 p.m. OFF TIME – 2:15 p.m.** The rider on the #7, “One Sunday,” Julian Pimentel, was changed to Eric Camacho; no double jocks mount. #5, “Start the Music,” was a vet scratch. #1, “Tizsilk,” #6, “Bubbling Springs,” #12, “Shamroge,” and #13, “Alisa’s Engineer,” were scratched as main-track only. #14, “Nightscape,” was scratched as an alternate. #7, “One Sunday,” was selected for a blood gas test. **ORDER OF FINISH – “10 - 9 - 2 - 8.” Starters - 8**
