We approved scratches for today, reviewed veterinarian daily treatment sheets, and blood gas test results.

Administrative Hearings:

On Tuesday, August 21, 2012 a hearing was held for trainer Juan Vasquez. Trainer Vasquez's horse "Golden Phoenix," was late arriving to the paddock for the fourth race on Monday, August 20, 2012. After repeated prior warnings for being late, Mr. Vasquez was fined one-hundred (\$100.00) dollars for this violation.

FIRST RACE – POST TIME – 1:15 p.m. OFF TIME – 1:16 p.m. ORDER OF FINISH – "4 - 7 - 3 - 5." Starters - 8

SECOND RACE – POST TIME – 1:45 p.m. OFF TIME – 1:46 p.m. #9, "Temptations Song," was selected for a blood gas test. #4, "Barbara," was claimed by Brenda Rushing – Jonas Gibson. ORDER OF FINISH – "8 - 1 - 6 - 7." Starters - 9

THIRD RACE – POST TIME – 2:15 p.m. OFF TIME – 2:16 p.m. #1, "Firey Rockette," was a vet scratch. #9, "Victory Ghost," was scratched by the racing office to re-enter. ORDER OF FINISH – "8 - 7 - 5 - 4." Starters - 7

FOURTH RACE – ON THE TURF - POST TIME – 2:45 p.m. OFF TIME – 2:47 p.m. #5, "Sutton Road," and #7, "Sorry No Refunds," were scratched as main-track only. #12, "Seabet," was scratched as an alternate. #3, "My Luca," was selected for a blood gas test. INQUIRY IN STRETCH – No hold or claim of foul was lodged in this race. The #4, "I am American," ridden by Sheldon Russell was lugging in down the stretch, but did not interfere with any other horses. ORDER OF FINISH – "6 - 9 - 1 - 10." Starters - 9

FIFTH RACE – POST TIME – 3:15 p.m. OFF TIME – 3:17 p.m. #6, "Regal Solo," was selected for a blood gas test. ORDER OF FINISH – "4 - 3 - 5 - 1." Starters - 6

SIXTH RACE – POST TIME – 3:45 p.m. OFF TIME – 3:46 p.m. #1, “Escort,” was scratched as part of a same-owner entry. #2, “Homeboykris,” was selected for a Stewards special test. **ORDER OF FINISH – “7 - 5 - 3 - 2.” Starters - 8**

SEVENTH RACE – ON THE TURF - POST TIME – 4:15 p.m. OFF TIME – 4:15 p.m. #10, “Sharp Numbers,” and #11, “Diamondsdiplomat,” were scratched as alternates. #12, “Siegfried,” was scratched as a main-track only. #9, “Time for Tutt,” was selected for a blood gas test. **ORDER OF FINISH – “3 - 5 - 9 - 4.” Starters - 9**

EIGHTH RACE – “THE OUR MIMS OVERNIGHT STAKES” - POST TIME – 4:45 p.m. OFF TIME – 4:46 p.m. The rider on the #2, “Simmadownnow,” Sheldon Russell, was changed to Alex Cintron; no double jocks mount. #3, “Brook’s Secret,” and #6, “Robbinette,” were scratched as this is a stakes race. We canceled Superfecta wagering for this race as we were below six betting interests. **ORDER OF FINISH – “1 - 7 - 4 - 5.” Starters - 5**

NINTH RACE – POST TIME – 5:15 p.m. OFF TIME – 5:16 p.m. #4, “Mach Twelve,” #5, “Culpepper Colonel,” and #9, “Target the Gold,” were vet scratches. **ORDER OF FINISH – “1 - 6 - 8 - 7.” Starters - 6**
