Drug testing was performed today for four Assistant Starters, one Jockey, and one Valet. The Jockey tested positive for Cocaine. The jockey was taken off his mounts, and will be scheduled for a hearing in this matter.

Administrative Hearing:

Trainer G. Scott Powell was issued a hearing notice for his “Clenbuterol” positive, concerning the horse “Butch Cassidy LZP,” urine Sample D-07780. “Butch Cassidy LZP” finished second in the ninth race on Monday, August 27, 2012. Mr. Powell having waived his right to Stewards hearing, accepted a seven day suspension and five hundred (\$500.00) dollar fine. The horse “Butch Cassidy LZP” will be disqualified from all purse monies from the ninth race on Monday, August 27, 2012.
