Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, and blood gas test results.

FIRST RACE – POST TIME – 1:15 p.m. OFF TIME – 1:16 p.m. #1, “Kazachka,” was scratched as part of same-owner entry. **ORDER OF FINISH – “5 - 6 - 8 - 4.” Starters - 8**

SECOND RACE – POST TIME – 1:45 p.m. OFF TIME – 1:45 p.m. #1a, “Summer Hustler,” was scratched as part of a same-owner entry. #2, “Wolfcamp” and #6, “Hewitts,” were vet scratches. #7, “Mason’s Hope,” was selected for a blood gas test. #1, “Mineswept,” was claimed by Hesa Stable – Alejandro Reyes. **ORDER OF FINISH – “1 - 7 - 4 - 8.” Starters - 6**

THIRD RACE – OFF THE TURF - POST TIME – 2:16 p.m. OFF TIME – 2:18 p.m.
The distance for this race has been modified from the original seven and one half furlongs on the turf, to one mile on the main track. #1, “Papa Carlos,” was scratched as this race is off the turf. #8, “Blinding Ruby,” was scratched by the racing office to re-enter. #12, “Secret Knock,” and #14, “Water Tower,” were scratched as alternates. **ORDER OF FINISH – “2 - 5 - 10 - 13.” Starters - 10**

FOURTH RACE – POST TIME – 2:47 p.m. OFF TIME – 2:47 p.m. #1a, “Superstious Love,” was scratched as part of a same-owner entry. #2, “Cat Wiesel,” was a vet scratch. After a six-way shake, #7, “Banner Elk Lady,” was claimed by King Star – Juan Vazquez. **ORDER OF FINISH – “7 - 3 - 1 - 4.” Starters - 6**

FIFTH RACE – OFF THE TURF - POST TIME – 3:18 p.m. OFF TIME – 3:20 p.m. #1, “Namron” #3, “Compatriot” #7, “Wandering Kitten” #10, “Upper Afleet” and #11, “Whereisjohnshouse,” were scratched as this race is off the turf. #12, “Besame Suances” and #13, “Color Cam,” were vet scratches. #14, “Et Al,” was scratched as an alternate. #4, “Longshore,” was selected for a blood gas test. We canceled Superfecta wagering for this race as we were below six betting interests. #8, “Tinitus,” was selected for a Stewards special test. **ORDER OF FINISH – “9 - 8 - 5 - 4.” Starters - 5**

SIXTH RACE – POST TIME – 3:49 p.m. OFF TIME – 3:50 p.m. #1, “Rehab Mo,” was scratched as part of a same-owner entry. #8, “Mason,” was selected for a blood gas test. A claim in for the #7, “Phil the Bishop,” by King Star was “VOID” as the horse’s name was spelled incorrectly on the claim slip. **INQUIRY AT START** – The #8, “Mason,” hesitated at the start breaking slowly. The #2, “The Admiral’s flank,” was selected for a Stewards special test. **ORDER OF FINISH – “6 - 7 - 2 - 5.” Starters - 8**

SEVENTH RACE – OFF THE TURF - POST TIME – 4:20 p.m. OFF TIME – 4:21 p.m. Erasmo Martinez, the scheduled rider on the #10, “Regal Nurse,” was changed to Jevian Toledo. #1, “Coup” #2, “Grant Park” #5, “Poetic Kid” #7, “Lemons to Lemonade” #8, “Joy” #9, “Assateaque,” and #12, “Charged Cotton,” were scratched as this race is off the turf. #1a, “Nashindy,” was scratched as an alternate. **ORDER OF FINISH – “3 - 4 - 10 - 6.” Starters - 5**

EIGHTH RACE – POST TIME – 4:52 p.m. OFF TIME – 4:55 p.m. Erasmo Martinez, the scheduled rider on the #5, “Lemon Juice,” was changed to Jevian Toledo. #9, “Steve’s Adventures,” was scratched by the racing office. After a two-way shake, #3, “Scallion,” was claimed by Midwest Thoroughbreds Inc – Jamie Ness. The owner and trainer that claimed #3, “Scallion,” requested a \$175.00 all inclusive special test. **INQUIRY IN STRETCH** - The Stewards saw no reason to take any action, making the race official. **ORDER OF FINISH – “1 - 2 - 4 - 5.” Starters - 9**

NINTH RACE – ARABAIANS - POST TIME – 5:22 p.m. OFF TIME – 5:22 p.m. Ryan Curatolo, the scheduled rider on the #5, “Sey Spottsproof,” was changed to Robert Paz. #5, “Sey Spottsproof,” was selected for a blood gas test. **ORDER OF FINISH – “1a - 3 - 5 - 4.” Starters -7**
