**Administrative Hearings:**

Two hearings were scheduled for Tuesday, June 9, 2013.

The first hearing was for Groom, Erik Rodriguez, for being intoxicated and disorderly in the stable area and involvement in a vehicle accident causing substantial property damage to Delaware Park (horse loading ramp). Subject did not have a driver's license, nor was the vehicle insured. As a result of the hearing, Mr. Rodriguez was fined the sum of \$250.00 and ordered to pay \$1,350.00 restitution to Delaware Park for damages incurred in the accident.

The second hearing was for Exercise Rider Mr. William Benitez, for failure to secure a license in a timely manner. As a result of the hearing, Mr. Benitez was fined the amount of \$100.00.
