Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, and blood gas test results.

**Equine Forensic Drug Testing:**

Post-race test results from Dalare Associates for July 3, and July 4, July 6, and July 8, 2013 were all clear with one exception. Sample #D-9497 retained from the horse, "Barracuda Wayne" from the 7<sup>th</sup> race on July 8, 2013 is currently on hold by the laboratory for further testing.

**Administrative:**

Associate Commission Veterinarian, Susan Botts is assisting Dr. Jane Teichner with Graded Stakes testing.

The barn and tack room for trainer Mr. Don Roberson was searched this morning. Results of the search revealed hypodermic needles, hypodermic syringes, and multiple vials of injectable medications. Horses trained and entered by Mr. Roberson, will be scratched. A hearing will be scheduled concerning this matter.

One jockey was tested today for drugs and alcohol which resulted in a negative test result.

**SECOND RACE – OFF THE TURF - POST TIME – 1:50 p.m. OFF TIME – 1:50 p.m.** #1, "Swoop" #1a, "Mavourneen" #4, "Coastin Along" and #6, "Cactusa," were scratched as this race is off the turf. **ORDER OF FINISH – "10 - 2 - 9 - 5." Starters - 7**

**THIRD RACE – POST TIME – 2:20 p.m. OFF TIME – 2:21 p.m.** #1, "Karen's Good Boy," was scratched by the Stewards. #1a, "Eiswein" and #2b, "Delvin's a Hater," were scratched as part of a same-owner entry. #6, "Keystone Daddy," was selected for a blood gas test. **ORDER OF FINISH – "8 - 6 - 3 - 2." Starters - 7**

**FOURTH RACE – POST TIME – 2:50 p.m. OFF TIME – 2:53 p.m.** #6, “Longshore,” was scratched by the racing office, as the horse was entered in the wrong race. #2, “King Touch,” was scratched at one minute to post by Chief Commission Veterinarian John Peters for being off in the right front. **ORDER OF FINISH – “4 - 3 - 1 - 7.” Starters - 5**

**FIFTH RACE – OFF THE TURF - POST TIME – 3:20 p.m. OFF TIME – 3:21 p.m.** The distance for this race has been modified from the original seven and one half furlongs on the turf, to one mile on the main track. Francisco Garcia, the scheduled rider on the #3, “Achilles Quest,” was changed to Yamil Rosario. #9, “Fly’n Bayou,” was scratched by the racing office to re-enter. #7, “Appealing Style,” was scratched for track conditions. #5, “Gottalovethedrake” #8, “Beansntaters” and #10, “Stock Quote,” were scratched as this race is off the turf. **ORDER OF FINISH – “2 - 7 - 1 - 4.” Starters - 6**

**SIXTH RACE – POST TIME – 3:51 p.m. OFF TIME – 3:53 p.m.** #4, “Fudge E,” was scratched by the racing office to re-enter. #6, “Let’s Have Us One,” was a vet scratch. **ORDER OF FINISH – “1 - 10 - 2 - 3.” Starters - 7**

**SEVENTH RACE – OFF THE TURF - POST TIME – 4:22 p.m. OFF TIME – 4:23 p.m.** #6, “Vperiyod Seryoga,” was a vet scratch. #1, “Lake Nona” #4, “Pyro City” and #8, Boogie Biz,” were scratched as this race is off the turf. #14, “Eriugena (IRE),” was scratched as an alternate. #10, “Greek Default,” was selected for a blood gas test. #9, “Edson’s Ridge,” was claimed by Stewart A. Nickel – Hugh McMahon. **ORDER OF FINISH – “13 - 3 - 10 - 5.” Starters - 9**

**EIGHTH RACE – THE DELAWARE OAKS (Grade II) - POST TIME – 4:53 p.m. OFF TIME – 4:57 p.m.** All horses for this race were pre-race blood gas tested. **ORDER OF FINISH – “7 - 8 - 9 - 5.” Starters - 9**

**NINTH RACE – OFF THE TURF - THE ROBERT G. DICK MEMORIAL STAKES (Grade III) - POST TIME – 5:24 p.m. OFF TIME – 5:27 p.m.** The distance for this race has been modified from the original one mile and three-eighths on the turf to one mile and one-quarter on the main track. All horses for this race were pre-race blood gas tested. Alex Cintron, the scheduled rider on the #2, “Angel Terrace,” was changed to Joshua Navarro. #1, “Laughing (IRE)” #1a, “Tannery (IRE)” #7, “Qushchi” #8, “Valiant Girl (GB)” and #9, “Aigue Marine, (GB),” were scratched as this is a stakes race. **ORDER OF FINISH – “3 - 2 - 5 - 6.” Starters - 5**

**TENTH RACE – ARABIANS - POST TIME – 5:55 p.m. OFF TIME – 5:56 p.m.** Maria Remedio, the scheduled rider on the #3, “Aim Hi,” was changed to Eddie Juardo. #3, “Adios Vacquero,” was selected for a blood gas test. **ORDER OF FINISH – “5 - 3 - 1a - 6.” Starters - 8**
