Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, and blood gas test results.

### **Equine Forensic Drug Testing:**

Graded stakes tests for July 20, were all clear. Post-race test results from Dalare Associates for July 18, July 20, and July 22, 2013 were all clear, with one exception. Sample #D-9476 retained from the horse, "NEW YAWKER" which ran in the 6<sup>th</sup> race on June 18, 2013, tested positive for excessive levels of "Phenylbutazone," in the amount of 2.60 micrograms per milliliter of plasma. Commission Inspector Swift conducted a barn search of trainer Julio Cartagena regarding the positive test. Inspection of the barn and tack rooms assigned to trainer Cartagena revealed "Phenylbutazone" Boluses. An interview of subject's veterinarian, Dr. DeLatte was also conducted. Mr. Cartagena waived his right to a split sample, and a hearing in this matter, accepting the \$500.00 dollar fine for a first offense under rule 15.1.3.1.5.
