Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, and blood gas test results.

FIRST RACE – POST TIME – 1:15 p.m. OFF TIME – 1:17 p.m. Two claims in for the #6, “The Gold Identity,” were VOID as the horse was scratched by the Stewards. The #6 unseated the rider in the post parade running off approximately five-eighths of a mile, before being caught by the outriders. The rider of the #6 Julian Pimentel was examined by E.M.T. Cathy Lancaster, who stated that Mr. Pimentel had signed a refusal of treatment form and will continue riding. **ORDER OF FINISH – “4 - 2 - 8 - 7.” Starters - 7**

SECOND RACE – POST TIME – 1:45 p.m. OFF TIME – 1:46 p.m. The rider on the #2, “Quarterback Sneak,” Jose L. Torres, should be Juan R. Torres. #1, “Royal Jacob,” was claimed by Anthracite Stable – Sam Cronk. #5, “Carol’s Jimmy,” was selected for a Stewards special test. **ORDER OF FINISH – “7 - 6 - 1 - 5.” Starters - 8**

THIRD RACE – POST TIME – 2:16 p.m. OFF TIME – 2:17 p.m. #7, “Very Few Details,” was selected for a blood gas test. **ORDER OF FINISH – “5 - 3 - 2 - 7.” Starters - 7**

FOURTH RACE – OFF THE TURF - POST TIME – 2:47 p.m. OFF TIME – 2:48 p.m. The distance for this race was changed from about One Mile and Seventy Yards on the turf, to One Mile and Seventy Yards on the dirt. #3, “Big Zapple,” was scratched as this race is off the turf. #6, “Coco Knows,” was scratched by the racing office to re-enter. #9, “Dapper Dude,” was a vet scratch. **INQUIRY AT THE START -** #10, “Marriage Fever,” ducked in at the start, putting pressure on the inside horses. The Stewards determined there was no reason to take any action. **ORDER OF FINISH – “8 - 1 - 11 - 4.” Starters - 8**

FIFTH RACE – POST TIME – 3:16 p.m. OFF TIME – 3:19 p.m. #7, “Willow Creek,” was selected for a blood gas test. After a two-way shake #3, “Virginia Ann,” was claimed by PTK LLC – Dane Kobiskie. #5, “Harbor Fox,” was claimed by Kryskaly Horse Racing Inc. – Julio Cartagena. **ORDER OF FINISH – “3 - 5 - 9 - 7.” Starters - 10**

SIXTH RACE – THE STRIKE YOUR COLORS STAKES (Div) - POST TIME – 3:50 p.m. OFF TIME – 3:53 p.m. Julian Pimentel, the scheduled rider on the #5, “Mr. Rover,” was changed to Victor Carrasco. #4, “My Corinthian,” was scratched as this is a stake race. **ORDER OF FINISH – “8 - 7 - 3 - 6.” Starters - 7**

SEVENTH RACE – OFF THE TURF - POST TIME – 4:22 p.m. OFF TIME – 4:23 p.m. The distance for this race was changed from about One Mile and Seventy Yards on the turf, to One Mile and Seventy Yards on the dirt. Julian Pimentel, the scheduled rider on the #2, “Time Has Come,” was changed to Victor Carrasco. #11, “Smarty ‘n Me,” was a vet scratch. #4, “Tinitus,” was scratched by the racing office. #7, “Mike the Leader” and #13, “Aridus,” were scratched by the racing office to re-enter. #5, “Hailstone” #6, “Robscarvic (IRE)” #8, “Nobody But You” #9, “Last Hurrah” and #12, “Tropic Sea,” were scratched as this race is off the turf. #10, “A. P. Cino,” was selected for a blood gas test. We canceled Show, Trifecta, and Superfecta wagering for this race as we were below five betting interests. **ORDER OF FINISH – “10 - 1 - 3 - 2.” Starters - 4**

EIGHTH RACE – THE STRIKE YOUR COLORS STAKES (Div) - POST TIME – 4:54 p.m. OFF TIME – 4:56 p.m. #2, “Theoryofrelativity” and #3, “Prestons Prince,” were scratched as this is a stakes race. #7, “No Fruit Degroote,” was selected for a blood gas test. **ORDER OF FINISH – “4 - 7 - 5 - 8.” Starters - 6**

NINTH RACE – POST TIME – 5:26 p.m. OFF TIME – 5:28 p.m. #2, “Bellamy Fleet,” was claimed by King Star – Juan Vazquez. After a two-way shake #5, “Hiram,” was claimed by D. Scott Peck – Owner - Trainer. **ORDER OF FINISH – “2 - 8 - 5 - 1.” Starters - 9**
