**FIRST RACE – POST TIME – 1:15 p.m. OFF TIME – 1:19 p.m.** Brian Pedroza, the scheduled rider on the #2, “Royale Jacob,” was changed to Alex Cintron. **ORDER OF FINISH – “5 - 2 - 3 - 6.” Starters - 6**

**SECOND RACE – POST TIME – 1:47 p.m. OFF TIME – 1:49 p.m.** #3, “Mine N Gems,” was a vet scratch. #5, “Lemon Juice,” was claimed by Guy Eubanks – Annette Eubanks. **ORDER OF FINISH – “5 - 7 - 2 - 4.” Starters - 6**

**THIRD RACE – POST TIME – 2:17 p.m. OFF TIME – 2:18 p.m.** Daniel Coa, the scheduled rider on the #1, “R B With Promise,” was changed to Abel Castellano Jr. #6, “Ledokol,” was a vet scratch. #1, “R B With Promise,” was selected for a blood gas test. **INQUIRY IN THE STRETCH –** Hold and claim of foul by the trainer of the #4, “Torpedo Cat,” Anthony Pecoraro, and the rider Victor Carrasco, against the #7, “Petie’s Boy,” with rider Xavier Perez, for allegedly coming in bumping him in the stretch. After reviewing the films and talking to the riders involved, the #7 came in down the stretch bumping the #4; the #7 was disqualified from second and placed third behind the #4, who was moved up from third to second. **ORDER OF FINISH – “2 - 4 - 7 - 1.” Starters - 6**
