FIRST RACE – POST TIME – 1:20 p.m. OFF TIME – 1:20 p.m. #3, “Put It On Me,” was scratched by the racing office to re-enter. #2, “Friday’s Gift,” was selected for a blood gas test. #5, “Political Pupil,” was claimed by PTK,LLC – Dane Kobiskie.

The owner and trainer that claimed the #5, “Political Pupil,” requested a \$175.00 all inclusive special test. #8, “Classy Citizen,” was claimed by Tsunebuni & Sekie Yoshihara – H. Graham Motion. **ORDER OF FINISH – “8 - 1 - 2 - 4.” Starters - 7**

SECOND RACE – POST TIME – 1:50 p.m. OFF TIME – 1:51 p.m. Vince Halliday, the scheduled rider on the #5, “Tinder Lord,” was changed to Yamil Rosario. Clayan Millwood, the scheduled rider on the #3, “Smarty ‘N me,” was changed to Juan Torres. After a two-way shake, #8, “Graced,” was claimed by Happy Hour Stable LLC – Paul McClelland. #10, “Yankee Mickey,” was claimed by Juan Arriagada – Heather Hollahan. #5, “Tinder Lord,” was pulled up after the race at the 7/8 pole and was removed from the racing surface via horse ambulance. Chief Commission Veterinarian, John Peters called, stating that the horse had re-injured a bowed tendon in the left front. **ORDER OF FINISH – “8 - 7 - 10 - 9.” Starters - 10**

THIRD RACE – POST TIME – 2:20 p.m. OFF TIME – 2:21 p.m. #1, “The Shermanator,” was a vet scratch. #6, “Sandshades,” was selected for a blood gas test. **Hold and claim of foul.** Trainer Michael Pino, and rider Victor Carrasco, of the #7, “Qahr,” claimed foul against the #6, “Sandshades,” ridden by Daniel Coa, for allegedly forcing the #7 out, at the top of the stretch. After reviewing the films and talking to the riders involved, the #6 comes out at the top of the stretch impeding and forcing the #7, wide. Subsequently, the #6 was disqualified from first and placed third behind the #7, who was moved up from third to second. **ORDER OF FINISH – “2 - 7 - 6 - 4.” Starters - 6**

SEVENTH RACE – POST TIME – 4:20 p.m. OFF TIME – 4:21 p.m. #1, “Dixie Emperor” #3, “Hyarima” #4, “Tiz Relevant” and #5, “Back Room Deal,” were vet scratches. #11, “Navy Wings,” was selected for a Stewards special test. **ORDER OF FINISH – “7 - 9 - 8 - 11.” Starters - 7**

EIGHTH RACE – ON THE TURF - THE ROSENNA STAKES - POST TIME – 4:50 p.m. OFF TIME – 4:51 p.m. Kaylia Albright, the scheduled rider on the #10, “Nasty Noozie,” was changed to Matthew Rispoli. #1, “Welcome Guest” #2, “Inimitable Romance” #9, “Idle Talk” and #13, “Dinner’s Out,” were scratched as this is a stakes race. #8, “Sixth and Arch,” was selected for a blood gas test. **ORDER OF FINISH – “6 - 12 - 7 - 8.” Starters - 9**

NINTH RACE – POST TIME – 5:20 p.m. OFF TIME – 5:21 p.m. #4, “Cape to Fear,” was scratched by the racing office to re-enter. **ORDER OF FINISH – “7 - 9 - 6 - 10.” Starters - 11**
