Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, and blood gas test results.

FIRST RACE – POST TIME – 1:15 p.m. OFF TIME – 1:16 p.m. Josue Arce, the scheduled rider on the #2, “More Glitter,” was changed to Victor Carrasco.#1, “Written Consent,” was a vet scratch. After a two-way shake, #7, “Ed’s Lion,” was claimed by Juan Arriagada – Heather Hollahan. **ORDER OF FINISH – “9 - 7 - 3 - 5.” Starters - 8**

SECOND RACE – POST TIME – 1:45 p.m. OFF TIME – 1:46 p.m. INQUIRY AT THE START– Hold and claim of foul by the #5, “Only Exception,” with rider Jevian Toledo, against the #4, “Blushing Touch,” with rider Julian Pimentel, for coming out bumping him at the start. After reviewing the films of the race and talking to the riders involved, the Stewards determined there was no reason to take any action. **INQUIRY IN THE STRETCH** - Hold and claim of foul by the #7, “Quiet Tiara,” with rider Michael Sandoval, against the #4, “Blushing Touch,” with rider Julian Pimentel, for coming out in front of him in the stretch. After reviewing the films of the race and talking to the riders involved, the Stewards determined there was no reason to take any action. **ORDER OF FINISH – “3 - 4 - 5 - 6.” Starters - 7**

THIRD RACE – POST TIME – 2:17 p.m. OFF TIME – 2:20 p.m. #7, “Clapping,” was selected for a blood gas test. #5, “Melody Pomeroy,” was claimed by Sola Dei Gloria Stable – Hugh McMahon. **ORDER OF FINISH – “3 - 2 - 5 - 7.” Starters - 7**

FOURTH RACE – ON THE TURF - POST TIME – 2:47 p.m. OFF TIME – 2:50 p.m. #2, “Ima Swinger” and #3, “Devine Sara,” were vet scratches. #11, “Bunhead” #13, “Controlled Neglect” and #14, “Cactusa,” were scratched as alternates. **ORDER OF FINISH – “9 - 6 - 12 - 5.” Starters - 9**

FIFTH RACE – POST TIME – 3:19 p.m. OFF TIME – 3:20 p.m. #1, “Mineswept,” was scratched as part of a same-owner entry. #5, “Everybody’s Daddy,” was selected for a blood gas test. A claim in for the #4, “Bet the Power,” by Hugh McMahon, was **VOID** as the claim form was not filled out properly. **ORDER OF FINISH – “5 - 4 - 7 - 6.” Starters - 7**

SIXTH RACE – ON THE TURF - POST TIME – 3:50 p.m. OFF TIME – 3:53 p.m. This race was declared a no contest, with all wagers on this race ordered refunded. The Stewards had to stop the race, due to the rider of the #2, “Classical Destiny,” Kristina McManigell, being unseated. The rider could not be removed from the racing surface immediately; the Stewards stopped the race with the use of the track warning system, and the outriders. An **INQUIRY** was called in this race, but it is undetermined what had caused the fall, as the films were inconclusive. The rider, Kristina McManigell, was transported to the hospital for evaluation.

SEVENTH RACE – POST TIME – 4:29 p.m. OFF TIME – 4:30 p.m. Joe Bravo, the scheduled rider on the #7, “Cosmic Energy,” was changed to Julian Pimentel. #6, “Off My Cloud,” was selected for a blood gas test. **ORDER OF FINISH – “1 - 8 - 5 - 3.” Starters - 8**

EIGHTH RACE – THE CARL HANFORD MEMORIAL STAKES - POST TIME – 4:58 p.m. OFF TIME – 5:01 p.m. #6, “I’m Steppin It Up,” was selected for a blood gas test. **ORDER OF FINISH – “3 - 1 – 6-7 DEAD HEAT - 8.” Starters – 8**

NINTH RACE – ON THE TURF - POST TIME – 5:30 p.m. OFF TIME – 5:34 p.m. #7, “Namron,” was a vet scratch. #1a, “Sharp Harbour” and #13, “California Kid,” were scratched as alternates. #5, “Tapinintovictory” and #9, “Sheriff Silverstar,” were scratched as main-track-only. **ORDER OF FINISH – “1 - 4 - 12 - 6.” Starters - 9**
