The two samples that were on hold, Sample #D-8946 retained from the horse, "Warrioroftheros" from the 9<sup>th</sup> race on September 14, 2013 and Sample #D-8925 retained from the horse, "War Prospector" from the 10<sup>th</sup> race on September 14, 2013, were released by the Dalare Associates, the official laboratory of the DTRC.

Starters - 6**

**THIRD RACE – POST TIME – 2:16 p.m. OFF TIME – 2:17 p.m. #1a,** “Peaceadaaction,” was scratched as part of a same-owner entry. #2, “Battery Backup,” was a vet scratch. #3, “Andersonstate,” was selected for a blood gas test. We canceled Superfecta wagering for this race as we were below six betting interests. After a two-way shake, #1, “My Charming Clyde,” was claimed by Midwest Thoroughbreds Inc - Jamie Ness. The new connections of the #1, “My Charming Clyde,” requested a \$175.00 all inclusive special test. #4, “Narbona Pass,” stumbled at the start. **ORDER OF FINISH – “6 - 1 - 5 - 3.” Starters - 5**

**FOURTH RACE – POST TIME – 2:47 p.m. OFF TIME – 2:4 p.m.** Hector Ramos, the scheduled rider on the #1, “I Forget,” was changed to Yamil Rosario. #5, “Prestons Princess,” was selected for a blood gas test. **ORDER OF FINISH – “4 - 6 - 2 - 3.” Starters - 6**

**FIFTH RACE – ON THE TURF - POST TIME – 3:18 p.m. OFF TIME – 3:22 p.m.** Luis Hiraldo, the scheduled rider on the #3, “Achilles Quest,” was changed to Yamil Rosario. **ORDER OF FINISH – “2 - 4 - 7 - 3.” Starters - 7**

**SIXTH RACE – POST TIME – 3:50 p.m. OFF TIME – 3:51 p.m.** #4, “Draxhall Woods” and #6, “A Student,” were vet scratches. #5, “Special Kid,” was claimed by Edward M. Johnson – Donald Krone. #3, “Southern Beach,” was eased at the quarter pole; the rider Kendrick Carmouche jumped off after he pulled the horse up. The #3 horse was attended by Dr. John Peters, who placed the horse’s injured left leg in a Kimzey brace. The injured horse was thereafter removed from the racing surface via horse ambulance. **ORDER OF FINISH – “8 - 7 - 2 - 5.” Starters - 6**

**SEVENTH RACE – ON THE TURF - POST TIME – 4:22 p.m. OFF TIME – 4:27 p.m.** #10, “Good Prize,” was scratched by the racing office to re-enter. #11, “Tiz Nasty (IRE),” was scratched as a main-track only. #5, “Chollie D,” was selected for a blood gas test. **INQUIRY AT THE TOP OF STRETCH -** The #2, “To Dare Is to Do,” ridden by Gabriel Saez, ducked in at the top of the stretch broke through the turf rail and unseated its rider. Subsequently, Jockey Saez was transported to hospital to be evaluated. **ORDER OF FINISH – “7 - 5 - 9 - 4.” Starters - 10**

**EIGHTH RACE – ARABIANS - POST TIME – 4:55 p.m. OFF TIME – 4:56 p.m.** **ORDER OF FINISH – “4 - 6 - 2 - 1.” Starters - 6**

**NINTH RACE – ARABIANS - POST TIME – 5:26 p.m. OFF TIME – 5:26 p.m.** #7, “Burning Ghost,” was selected for a blood gas test. **ORDER OF FINISH – “6 - 2 - 1 - 4.” Starters - 7**
