



Daily Log Stewards Report Delaware Park

Date: Monday, October 7, 2013 **Racing Day: # 81**
Weather: Cloudy, Chance of Rain Low 70's
Track - Fast Turf – OFF **1:15 post time**

Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, and blood gas test results.

Equine Forensic Drug Testing:

Post-race test results from Dalare Associates for September 28 and September 30, 2013, were all clear.

FIRST RACE – POST TIME – 1:15 p.m. OFF TIME – 1:16 p.m. Yamil Rosario, the scheduled rider on the #7, “Hobson B,” was changed to Santos Chavez. #3, “If I Win Thelotto,” was selected for a blood gas test. #5, “Ride I’Ultimo,” ridden by Christian Olmo, fell after the race while being pulled up at the six and one half furlong marker. Jockey Olmo stepped off the horse and was uninjured. Associate Commission Veterinarian Jane Teichner reported that “RIDE I’ULTIMO” was dead. The horse was removed from the racing surface via horse ambulance. **ORDER OF FINISH – “2 - 6 - 1 - 4.” Starters – 8**

Note: “RIDE I’ULTIMO” was sent to New Bolton Center by order of the DTRC Executive Director to determine cause of death.

SECOND RACE – POST TIME – 1:45 p.m. OFF TIME – 1:46 p.m. INQUIRY AT THE START - #6, “Sumo,” with rider Abel Castellano Jr., was declared a non-starter for all wagering purposes because he was precluded from a fair start. Our decision was based on that the assistant starter failed to turn the #6 horse loose when the gates opened. **ORDER OF FINISH – “2 - 4 - 5 - 3.” Starters – 7**

THIRD RACE – POST TIME – 2:15 p.m. OFF TIME – 2:15 p.m. The main track was downgraded to (**Muddy**) starting with this race. Jorge Vargas Jr., the scheduled rider on the #2, “Back Bayou,” was changed to Christian Olmo. Yamil Rosario, the scheduled rider on the #6, “Distortedredhead,” was changed to Victor Carrasco. #1, “Harling’s Darling,” was scratched as part of a same-owner entry. #4, “Coin of the Realm,” was a vet scratch. #3, “Sweet Boo,” was selected for a blood gas test. After a two-way shake, #8, “Lucky Lady Lawyer,” was claimed by Frank D. Light – Owner-Trainer. **ORDER OF FINISH – “8 - 5 - 3 – 1a.” Starters - 7**

FOURTH RACE – OFF THE TURF - POST TIME – 2:45 p.m. OFF TIME – 2:45 p.m. THE RACES WERE TAKEN OFF THE TURF at 2:05 P.M. The main track was downgraded to (**Sloppy**) starting with this race. #1a, “Rustler Hustler,” was scratched as part of a same-owner entry. #3, “Umbraggio,” was a vet scratch. #6, “Kentucky Reign,” was scratched as this race was taken off the turf. #7, “St Moose” and #8, “Rush Now,” were scratched as a main-track only. #5, “Political Courage” and #10, “Best Actor,” were trainer scratches. We canceled Show, Trifecta, and Superfecta wagering for this race as we were below five betting interests. **ORDER OF FINISH – “2 - 1 - 4 - 9.” Starters - 4**

FIFTH RACE – POST TIME – 3:15 p.m. OFF TIME – 3:20 p.m. #7, “Rebeldia,” was selected for a blood gas test. Upon the recommendation of Associate Commission Veterinarian Jane Teichner, the #3, “Dina’s Touch,” was scratched at one minute to post, for not warming up well. **ORDER OF FINISH – “6 - 1 - 5 - 7.” Starters - 7**

SIXTH RACE – OFF THE TURF - POST TIME – 3:46 p.m. OFF TIME – 3:47 p.m. #4, “Win for Kitten,” was a vet scratch. #1, “Swoop” #2, “April’s Dixie Bell” #3, “Nekia’s Vow” #8, “Starry” and #9, “Lucky Empress,” were scratched as this race was taken off the turf. #7, “I’m a Lucky Lady” #10, Long Legged Girl” and #11, “Trick the Queen,” were scratched as main-track only. We canceled Place, Show, Exacta, Trifecta, and Superfecta wagering for this race as we were below four betting interests. **ORDER OF FINISH – “5 - 6 - 12.” Starters - 3**

SEVENTH RACE – POST TIME – 4:15 p.m. OFF TIME – 4:16 p.m. #3, “Battery Backup,” was scratched by the racing office. #4, “Escrow Kid,” was claimed by Donald C. Wilson – Carl Doran. #8, “Lemon Juice,” was claimed by Marion Smith – Kenny Smith. **ORDER OF FINISH – “4 - 7 - 9 - 1.” Starters - 9**

EIGHTH RACE – OFF THE TURF - THE JUSTAKISS STAKES - POST TIME – 4:45 p.m. OFF TIME – 4:46 p.m. #1, “Ski Holiday,” was scratched as part of a same-owner entry. #2, “Welcome Dance” #5, Tabreed (GB)” #6, “Tippie Tap,” #7, “Dinner’s Out (GB)” #9, “Welcome Guest,” and #10, “Whatabootie,” were scratched in compliance with stakes race provision rule 11.14.1.1. We canceled Show, Trifecta, and Superfecta wagering for this race as we were below five betting interests. **ORDER OF FINISH – “4 - 8 – 1a - 3.” Starters - 4**

NINTH RACE – ARABIANS - POST TIME – 5:15 p.m. OFF TIME – 5:15 p.m. #7, “Lucky Sand,” was scratched by its trainer. #5, “Sugar Sand,” was selected for a blood gas test. **ORDER OF FINISH – “4 - 8 - 2 - 3.” Starters - 7**
