Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, and blood gas test results.

Equine Forensic Drug Testing:

- Post-race test results from L.G.C. Sports Science for Wednesday, July 2, 2014 were all clear except samples #41432, #41434, #41435, and #41436 which are on hold awaiting a certificate of analysis.

SECOND RACE – ON THE TURF - POST TIME – 1:45 p.m. OFF TIME – 1:49 p.m. Yamil Rosario, the scheduled rider on the #2, "Hochman," was changed to Carol Cedeno; no double jocks mount. #11, "The Morning Guys," was scratched by the racing office to re-enter. #14, "Penn Square," was scratched as an alternate. #7, "Lets Get It Going," was selected for a blood gas test. **ORDER OF FINISH – "6 - 13 - 3 - 5."** Starters – 12

THIRD RACE – POST TIME – 2:18 p.m. OFF TIME – 2:19 p.m. #2, “Dash of Dazzle,” was selected for a blood gas test. **ORDER OF FINISH – “3 - 7 - 5 - 1.” Starters - 8**

FOURTH RACE – ON THE TURF - POST TIME – 2:47 p.m. OFF TIME – 2:50 p.m. Luis Garcia, the scheduled rider on the #6, “Capital Fellow,” was changed to J. D. Acosta; no double jocks mount. #13, “Zuerstgold,” was scratched as a main-track only. #14, “Bakyt,” was scratched as an alternate. **ORDER OF FINISH – “2 - 9 - 4 - 3.” Starters - 12**

FIFTH RACE – POST TIME – 3:19 p.m. OFF TIME – 3:20 p.m. #1 “Into the Forest,” was scratched by the racing office to re-enter. #8, “Vindicated,” was a vet scratch. After a three-way shake, #5 “Tiz Showbiz,” was claimed by Vince Campanella – Alexander Delp. **ORDER OF FINISH – “5 - 6 - 9 - 3.” Starters - 7**

SIXTH RACE – THE FORT DELAWARE STAKES - POST TIME – 3:48 p.m. OFF TIME – 3:49 p.m. #1, “Royal Currier,” was scratched in compliance with stakes race provision rule 11.14.1.1. #3, “King Henry,” was selected for a blood gas test. **INQUIRY SHORTLY AFTER THE START AND JUST PAST THE THREE-QUARTERS CHUTE** – William Otero, the rider of the #3, “King Henry,” put the race on hold and claimed foul shortly after the three-quarter chute, also the rider of the #4, “Dagburnit,” Daniel Centeno, put the race on hold and claimed foul shortly after start. Both claims of foul were against the #5, “Pico’s Pride,” with rider Alex Cintron. After reviewing the video, the Stewards determined that the #5 came in on the #4 shortly after the start, causing the #4 to clip heels, and impeding the #3 just past the three-quarter chute. The Stewards disqualified the #5 from first and placed him seventh behind the #3 who was moved up to fourth, and the #4 who was moved up to sixth **ORDER OF FINISH – “2 - 6 - 7 - 3.” Starters - 7**

SEVENTH RACE – THE SWEET AND SASSY STAKES - POST TIME – 4:18 p.m. OFF TIME – 4:21 p.m. Anthony Black, the scheduled rider on the #5, “Winning Image,” was changed to Jose Caraballo; no double jocks mount. #1, “Conga Bella,” and #9, “Ms. Cruisen’,” were scratched in compliance with stakes race provision rule 11.14.1.1. #2, “Awesome Mama,” was selected for a blood gas test. **ORDER OF FINISH – “3 - 5 - 4 - 7.” Starters - 7**

EIGHTH RACE – ON THE TURF - THE CAPE HENLOPEN STAKES - POST TIME – 4:45 p.m. OFF TIME – 4:53 p.m. Luis Garcia, the scheduled rider on the #1, “Vitium,” was changed to Angel Quinones; no double jocks mount. #10, “Chamois,” was scratched in compliance with stakes race provision rule 11.14.1.1. **ORDER OF FINISH – “3 - 6 - 5 - 11.” Starters - 11**
