Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, and blood gas test results.

### Equine Forensic Drug Testing:

- Post-race test results from L.G.C. Lexington Sports Science for Thursday, June 5, and Saturday, June 7, 2014 were all clear, with the following exceptions: For Thursday, June 5, 2014 samples #44502, #44508, and #44510 are on hold, awaiting a certificate of analysis.
- Post-race test results from L.G.C. Lexington Sports Science for Saturday, June 7, 2014 were all clear, with the following exceptions: Samples #44537 and #44539 are on hold, awaiting a certificate of analysis.
- Post-race test results from L.G.C. Lexington Sports Science for Monday, June 9, 2014 were all clear, with the following exceptions: Samples #44546, #44547, #44548, #44552 and #44553 are on hold, awaiting a certificate of analysis.

We conducted a hearing this morning for Trainer Juan Vazquez, concerning disorderly conduct and fighting at the scales area following the running of the fourth race on Monday, June 23, 2014. **FIRST RACE – POST TIME – 1:15 p.m. OFF TIME – 1:16 p.m.** #4, “Real Strike,” was a vet scratch. #2, “Ms. Clampett,” broke down, being pulled up at the 5/16 pole. The #2 was examined by Associate Commission Veterinarian Jane Teichner, who reported that the #2 had broken its left front leg, and was humanely destroyed. The rider of the #2 Yomar Ortiz, was uninjured, as he had dismounted holding the horse until the outrider arrived. **ORDER OF FINISH – “7 - 6 - 1 - 3.” Starters - 6**

**SECOND RACE – ON THE TURF - POST TIME – 1:45 p.m. OFF TIME – 1:49 p.m.** #4, “Charlie Sunshine,” was scratched as a main-track only. #5, “Hailey’s Star,” and #11, “Miss Pavarotti,” were scratched by the racing office to re-enter. #7, “Michelle’s Trip,” was selected for a blood gas test. **ORDER OF FINISH – “9 - 1 - 2 - 6.” Starters - 8**

**THIRD RACE – POST TIME – 2:17 p.m. OFF TIME – 2:18 p.m.** #4, “The Great Milenko,” was scratched by the racing office to re-enter. #3, “Yellowknife Joe,” was selected for a blood gas test. #5, “Aces Are Wild,” was claimed by Helen Marshall – Kieron Magee. **ORDER OF FINISH – “3 - 6 - 2 - 5.” Starters - 6**

**SIXTH RACE – ON THE TURF - POST TIME – 3:48 p.m. OFF TIME – 3:51 p.m.** Forest Boyce the scheduled rider on the #11, “Smoke the Devil,” was changed to Victor Molina; no double jocks mount. #2, “Divine View,” and #5, “Small Town Talk,” were scratched as main-track only. #13, “State Flag,” was a vet scratch. #8, “Marriage Fever,” was selected for a blood gas test. **ORDER OF FINISH – “1 - 9 - 12 - 8.” Starters - 10**

**SEVENTH RACE – POST TIME – 4:20 p.m. OFF TIME – 4:29 p.m.** A claim submitted for the #4, “Out of Spells,” by Baltazar Galvin was VOID as the claim blank was filled out incorrectly. #8, “Four Star Princess,” was scratched prior to the start as she flipped in the starting gate and ran down the track before being apprehended by the outriders. #7, “Erzulie Dantor,” was also a late scratch, as the horse broke through the gate while the #8 was acting up. The #7 was also caught by the outriders after running off for 5/8 of a mile. **ORDER OF FINISH – “4 - 2 - 6 - 9.” Starters - 7**
