Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, and blood gas test results.

Equine Forensic Drug Testing:

Post-race test results from LGC in Kentucky, the official Laboratory for the Delaware Thoroughbred Racing Commission has returned a certificate of analysis for post-race test sample #40459. The certificate of analysis reports that sample #40459 for the horse "A.P. Wild," from the second race on May 21, 2014, contains "Stanozolol" the trainer of this horse, Juan Vazquez was informed of this matter by the Stewards. Inspectors Swift and Delaney conducted a barn search of trainer Juan Vazquez, regarding the positive test. Inspection of the barn and tack rooms assigned to trainer, Vazquez, revealed "Phenylbutazone" powder and paste. Subsequently, trainer Vazquez appeared before the Stewards, stating that he would exercise his right to a split sample.

Administrative:

We drug tested a trainer yesterday, who has tested negative for any prohibited substance. A decision by the Stewards has been rendered to Trainer Juan Vazquez, concerning disorderly conduct, and fighting at the scales area following the running of the fourth race on Monday, June 23, 2014 Mr. Vazquez will be fined \$2,500 suspended for a period of ninety days, and required to attend and complete an anger management program.
