After a two-way shake, #6, “Quick N Proud,” was claimed by Juan Arriagada – Heather Hollahan. #3, “Terry Blossom,” was selected for a blood gas test. **ORDER OF FINISH – “6 - 5 - 3 - 1.” Starters - 7**
