SECOND RACE – ON THE TURF - POST TIME – 1:45 p.m. OFF TIME – 1:49 p.m.
#4, “Sun Story,” was a vet scratch. #13, “Wildly Leaks,” and #14, “My Pal Tommy,” were
scratched as alternates. #5, “Colmont Kid,” was selected for a blood gas test. **ORDER OF**
