**FIRST RACE – POST TIME – 1:15 p.m. OFF TIME – 1:17 p.m. ORDER OF FINISH – “6 - 5 - 2 - 1.” Starters - 6**

**SECOND RACE – ON THE TURF - POST TIME – 1:45 p.m. OFF TIME – 1:50 p.m.** Jose Caraballo, the scheduled rider on the #1, “Atticus Finch,” was changed to Ricardo Chiappe; no double jocks mount. #7, “Mr Percussionist,” and #11, “All Q’d Up,” were scratched as main-track only. #5, “Jericho Call,” was selected for a blood gas test. **ORDER OF FINISH – “10 - 1 - 2 - 12.” Starters - 12**

**THIRD RACE – POST TIME – 2:19 p.m. OFF TIME – 2:22 p.m.** Daniel Centeno, the scheduled rider on the #7, “Wokeuponhomeplate,” was changed to Kerwin Clark; no double jocks mount. #7, “Wokeuponhomeplate,” was selected for a blood gas test. **INQUIRY AT THE START -** #4, “Amber Coast,” stumbled badly at the start. #5, “Stevia,” broke in a tangle, before regaining his footing. The Stewards saw no reason to take any action, making the race official. . **ORDER OF FINISH – “6 - 7 - 1 - 3.” Starters - 7**

**FOURTH RACE – ON THE TURF - POST TIME – 2:50 p.m. OFF TIME – 2:54 p.m.** #2, “Melora,” was a vet scratch. #3, “Mountain Sprite,” was scratched as a main-track only. **ORDER OF FINISH – “6 - 4 - 7 - 1.” Starters - 11**

**FIFTH RACE – POST TIME – 3:23 p.m. OFF TIME – 3:25 p.m.** #1, “Six Ring Sign,” was selected for a blood gas test. **ORDER OF FINISH – “4 - 2 - 6 - 7.” Starters - 7**

**SIXTH RACE – ON THE TURF - POST TIME – 3:52 p.m. OFF TIME – 3:57 p.m. #3,** “Baby Situation,” was scratched as a main-track only. #7, “Trouble in Love,” was a vet scratch. #6, “Kukosa,” was selected for a blood gas test. #12, “Heated Exchange,” was claimed by James C. Wolfe – Kieron Magee. **ORDER OF FINISH – “10 - 2 - 6 - 1.” Starters - 11**

**SEVENTH RACE – POST TIME – 4:26 p.m. OFF TIME – 4:28 p.m. #4,** “Rope,” and #6, “Grosero,” were vet scratches. #3, “Hope in Your Rope,” was claimed by Helen Marshall - Kieron Magee. After a two-way shake, #5, “Silvertonguedtommy,” was claimed by Worcester Investments LLC – Wayne Potts. We canceled Superfecta wagering for this race as we were below six betting interests. **ORDER OF FINISH – “5 - 2 - 7 - 1.” Starters - 5**

**EIGHTH RACE – ARABIANS - POST TIME – 4:56 p.m. OFF TIME – 4:59 p.m. #5,** “Bell South,” was selected for a blood gas test. #1, “Ivory Shores,” broke slowly. The rider of the #1, “Ivory Shores,” Gregorio Rivera, was hit in the face by the horse’s head while the horse was acting up in the gate. The Stewards called the EMT’s to go to the scale house to check on the rider after the race. The Stewards were informed that Mr. Rivera had suffered a concussion and was admitted to hospital. **ORDER OF FINISH – “6 – 2b - 4 - 7.” Starters - 9**
