SECOND RACE – OFF THE TURF - POST TIME – 1:46 p.m. OFF TIME – 1:47 p.m. #7, “Written Word,” and #8, “Big Zapple,” were scratched by the racing office. #10, “Blue Distortion,” was a vet scratch. #13, “High Intense,” was a trainer scratch. #14, “Doctor’s,” was scratched by its trainer. #11, “Jo Way Java,” reared up at the start, breaking slowly. **ORDER OF FINISH – “12 - 4 - 6 - 9.” Starters - 9**

THIRD RACE – POST TIME – 2:17 p.m. OFF TIME – 2:18 p.m. #5, “Skylar,” was a vet scratch. #2, “Satch,” was claimed by Mark Valentine – Anthony Pecoraro. **ORDER OF FINISH – “7 - 4 - 2 - 3.” Starters - 6**

FOURTH RACE (Continued) the rider of the #9, "Talk to Me," for coming in just past the three-eighths pole, taking his room away and causing him to check his horse. After reviewing the video which was inconclusive, the Stewards saw no reason to take any action, making the race official. **ORDER OF FINISH – "9 - 12 - 2 - 11." Starters - 8**

FIFTH RACE – POST TIME – 3:19 p.m. OFF TIME – 3:20 p.m. #4, "Respect the Flag," was scratched by the racing office to re-enter. #3, "Peaceful Boundary," was selected for a blood gas test. #5, "Can'tbeattheheat," pulled up lame after the race at the 6 1/2 furlong marker. The #5 was examined by Associate Commission Veterinarian Richard Brown, who placed the horse's left front leg in a Kimzey Brace. The horse was thereafter removed from the racing surface via horse ambulance. **ORDER OF FINISH – "1 - 6 - 5 - 7." Starters - 6**

SIXTH RACE – OFF THE TURF - POST TIME – 3:50 p.m. OFF TIME – 3:50 p.m. Ricardo Chiappe, the scheduled rider on the #2, "Nickyrocksforpops," was changed to Kristen Swan; no double jocks mount. Daniel Centeno, the scheduled rider on the #12, "Dream of Pegasus," was changed to Angel Serpa; no double jocks mount. #1, "Mavourneen," was a vet scratch. #4, "Charm City," was scratched by the racing office to re-enter. #5, "D'Orsay," #7, "Treasured," #8, "Northern Smile," and #13, "Patinka," were scratched as this race was taken off the turf. #14, "Nekia's Vow," was scratched by its trainer. #6, "Cherokee Kitten," stumbled at the start, breaking slowly. **ORDER OF FINISH – "3 - 11 - 2 - 6." Starters - 7**

SEVENTH RACE – POST TIME – 4:21 p.m. OFF TIME – 4:21 p.m. #2, "Liam's Song," was a vet scratch. #4, "Lawyer Dave," was selected for a blood gas test. **ORDER OF FINISH – "1 - 4 - 3 - 7." Starters - 6**

EIGHTH RACE – POST TIME – 4:52 p.m. OFF TIME – 4:54 p.m. #1a, "Melody Pomeroy," was scratched as part of a same-owner entry. #3, "Soft Ball," #4, "Sharpandwitty," #7, "Quiet Dinero," and #9, "Worthington Court," were vet scratches. #1, "Lily's Peak," was selected for a blood gas test. #5, "Mountain Sprite," was claimed by PTK LLC – Dane Kobiske. **ORDER OF FINISH – "8 - 6 - 10 - 2." Starters - 6**
