Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, and blood gas test results.

Equine Forensic Drug Testing:

Post-race test results from L.G.C. Science revealed the following:

- Samples collected on Wednesday, August 6, 2014 were all clear except sample #44970, which is on hold awaiting a certificate of analysis.
- A certificate of analysis for post-race test sample #44839 which was collected from the horse "Barracuda Wayne," who ran in the 3rd race on Saturday, July 12, 2014, contained "Dexamethasone" in the amount of 94 picograms per milliliter of plasma. The trainer, Murray Rojas, was informed of this matter by the Stewards.
- A certificate of analysis for post-race test sample #44937 which was collected from the horse, "Diski Dance," who ran in the 3rd race on Wednesday, July 23, 2014, contained the combination of "Flunixin" and "Phenylbutazone" with "Phenylbutazone" in the amount of 2.04 micrograms per milliliter of plasma. The trainer of this horse, Linda Albert, was informed of this matter by the Stewards.
