Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, and blood gas test results.

Equine Forensic Drug Testing:

Trainer Murray Rojas was contacted telephonically by the Stewards concerning sample #44839 which was collected from her horse "Barracuda Wayne," which ran in the 3rd race on July 12, 2014, which contained "Dexamethasone" in the amount of 94 picograms per milliliter of plasma. Ms. Rojas stated that she would exercise her right to a split sample.

FIRST RACE – POST TIME – 1:15 p.m. OFF TIME – 1:15 p.m. #6, "Gindini," was a vet scratch. #2, "Fortyshadesofgreen," was selected for a blood gas test. We canceled Superfecta wagering for this race as we were below six betting interests. #5, "Thrill Show," was claimed by Juan Arriagada – Heather Hollahan.

ORDER OF FINISH – "2 - 1 - 3 - 4." Starters - 5

SECOND RACE – ON THE TURF - POST TIME – 1:46 p.m. OFF TIME – 1:49 p.m. #3, "House Red," was a vet scratch. #1, "Gasparilla Float," and #8, "Talk to Me," were scratched as a main-track only. #6, "English Sarah," was selected for a blood gas test. Erasmo Martinez, the scheduled rider on the #7, "Push Kaiser," was changed to Jose Vega; no double jocks mount. **INQUIRY AT THE START** – The #11, "Sweet Soliloquy," lunged at the start, unseating its rider, Victor Carrasco. Jockey Carrasco walked off the track where he was examined by EMT Amy Trowbridge, who reported that the jockey was uninjured. The Stewards saw no reason to take any action and made the race official. #2, "Bonnie Lass," ridden by Javier Santiago, broke down in the stretch. Jockey Santiago was uninjured, as he had dismounted and held the horse until the arrival of the outrider and Chief Commission Veterinarian, John Peters. "Bonnie Lass" was examined by Dr. Peters, who diagnosed that the horse had sustained a fracture to its right front ankle. Due to the catastrophic injury, Dr. Peters humanely destroyed "Bonnie Lass."

THIRD RACE – POST TIME – 2:20 p.m. OFF TIME – 2:21 p.m. Carlos Luis Gutierrez, the scheduled rider on the #7, “Sampson County,” was changed to Nik Juarez; no double jocks mount.

ORDER OF FINISH – “6 - 3 - 4 - 1.” Starters - 7

FOURTH RACE – ON THE TURF - POST TIME – 2:52 p.m. OFF TIME – 2:55 p.m. #8, “Bethwithoutthehalo,” was scratched as a main-track only. **HOLD AND CLAIM OF FOUL:** Jockey Christian Santiago Reyes aboard the #1, “Smart N Smokin” lodged a claim of foul against Angel Castillo aboard the #2, “Sweet Emster” for coming out down the stretch bothering his horse. The Stewards reviewed the video and determined that the #2 was three-lengths in front and well clear of the #1, during the entire stretch run. No action was taken regarding the claim of foul and the race was made official. No Inquiry was called in this race by the Stewards.

SIXTH RACE – POST TIME – 3:58p.m. OFF TIME – 3:58 p.m. #1, “Bullet Mobile,” was selected for a blood gas test. #8, “Mummi’s Hope,” was claimed by Taking Risk Stable LLC – Ben Feliciano Jr.

ORDER OF FINISH – “3 - 4 - 1 - 8.” Starters - 8

SEVENTH RACE – ON THE TURF - POST TIME – 4:28 p.m. OFF TIME – 4:32 p.m. #1, “Foursouthernbelles,” and #2, “Epic Story,” were scratched as main-track only. #4, “Ceci N Red,” was selected for a blood gas test.
