Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, and blood gas test results.

FIRST RACE – POST TIME – 1:15 p.m. OFF TIME – 1:16 p.m. #6, “Gold Diggin Dixie,” was selected for a blood gas test.

ORDER OF FINISH – “5 - 2 - 4 - 3.” Starters - 6

SECOND RACE – POST TIME – 1:45 p.m. OFF TIME – 1:46 p.m. #8, “Key to a Cure,” was claimed by Happy Hour Stable LLC – Paul McClelland.

ORDER OF FINISH – “4 - 2 - 8 - 1.” Starters - 8

THIRD RACE – POST TIME – 2:15 p.m. OFF TIME – 2:17 p.m. Jean Pierre Vallellanes, the scheduled rider on the #2, “Maria’s Song,” was changed to Horatio Karamanos; no double jocks mount. #7, “Caribbean Song,” was selected for a blood gas test. Following the race, the #3, “Page an Angel,” ridden by Mauricio Rodriguez, pulled up sore near the seven-eighths pole. Jockey Rodriguez dismounted and unsaddled the horse. Associate Commission Veterinarian, Richard Brown examined the #3 and could detect nothing wrong. Subsequently, “Page an Angel” was removed from the racing surface via horse ambulance.

FOURTH RACE – ON THE TURF - POST TIME – 2:45 p.m. OFF TIME – 2:48 p.m. #1, “Whereisjohnshouse,” was a vet scratch. #2, “Pluracity,” #10 “Tapintovictory,” and #12, “Festive Spirit,” were scratched as main-track only. #4, “Slinger,” was scratched by the racing office. #11, “Northwood Bully,” was a trainer scratch. #3, “Foolish Tiger,” was selected for a blood gas test. #14, “Alicantino,” was claimed by Kieron Magee – Owner Trainer.

David Nava, the scheduled rider on the #3, “Portena,” was changed to Mohamed Osman; no double jocks mount. #5, “Dreaming of Jazz,” was selected for a blood gas test. A claim for the #2, “Wokeuponhomeplate,” by Wayne Potts – Owner Trainer was **VOID** as no race number was entered on the claim envelope.
